



1995 ASSEMBLY BILL 701

November 27, 1995 – Introduced by Representatives BLACK, BALDWIN and HANSON, cosponsored by Senator RISSER. Referred to Committee on Ways and Means.

1 **AN ACT to amend** 79.03 (1), 79.03 (3) (a), 79.06 (1) (b) and 79.06 (2) (b); and **to**
2 **create** 79.03 (2m) of the statutes; **relating to:** the maximum allowable loss in
3 shared revenue.

Analysis by the Legislative Reference Bureau

This bill creates a new shared revenue payment that ensures that the loss in shared revenue by a municipality or county will not exceed \$1,000,000 during any 10-year period.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

4 **SECTION 1.** 79.03 (1) of the statutes is amended to read:

5 79.03 (1) Each municipality and county is entitled to shared revenue,
6 consisting of an amount determined on the basis of population under sub. (2), plus
7 ~~an amount~~ the amounts determined under sub. subs. (2m) and (3).

8 **SECTION 2.** 79.03 (2m) of the statutes is created to read:

9 79.03 (2m) Each municipality and each county is entitled to a payment of an
10 amount that will ensure that its payments under this subchapter have not declined
11 by more than \$1,000,000 during the 10 years ending with the current year.

1 **SECTION 3.** 79.03 (3) (a) of the statutes is amended to read:

2 79.03 **(3)** (a) The amount in the shared revenue account for municipalities and
3 the amount in the shared revenue account for counties, less the payments under sub-
4 subs. (2) and (2m) and s. 79.04, shall be allocated to each municipality and county
5 respectively in proportion to its entitlement. In this paragraph, "entitlement" means
6 the product of aidable revenues and tax base weight.

7 **SECTION 4.** 79.06 (1) (b) of the statutes is amended to read:

8 79.06 **(1)** (b) If the payments to any municipality or county under s. 79.03,
9 excluding payments under s. 79.03 (2m) and (3c), in ~~1986~~ or any year thereafter are
10 less than 95% of the combined payments to the municipality or county under this
11 section and s. 79.03, excluding payments under s. 79.03 (2m) and (3c), for the
12 previous year, the municipality or county has an aids deficiency. The amount of the
13 aids deficiency is the amount by which 95% of the combined payments to the
14 municipality or county under this section and s. 79.03, excluding payments under s.
15 79.03 (2m) and (3c), in the previous year exceeds the payments to the municipality
16 or county under s. 79.03, excluding payments under s. 79.03 (2m) and (3c), in the
17 current year.

18 **SECTION 5.** 79.06 (2) (b) of the statutes, as affected by 1995 Wisconsin Act 27,
19 is amended to read:

20 79.06 **(2)** (b) If the payments to a municipality or county, except any county in
21 which there are no cities or villages, in any year exceed its combined payments under
22 this section and s. 79.03, excluding payments under s. 79.03 (2m) and (3c), in the
23 previous year by more than the maximum allowable increase, the excess shall be
24 withheld to fund minimum payments in that year under sub. (1) (c).

25 **SECTION 6. Initial applicability.**
