AN ACT to provide for the election of a Territorial Printer.

Be it enacted by the Council and House of Representatives of the Territory of Wisconin:

SECTION. 1. There shall be elected at the present session of When elected. the Legislative Assembly, and at every annual session thereafter, by joint ballot of the Council and the House of Representatives, a competent person to do such printing as may from time to time be required by law, whose term of service shall commence at vice. the close of the session at which he shall be elected, and continue one year and until his successor shall be elected and qualified:

Provided, however, that either house may by resolution provide for its own incidental printing.

SEC. 2. The printer so elected shall execute to the Treasurer of the Territory, to be approved by the Governor, a bond with one or more freeholders as sureties in the penal sum of three thousand and take oath. dollars, conditioned for the faithful performance of the duties imposed upon him by law. And the said printer shall also take an oath faithfully to discharge such duties; which bond and oath shall be filed in the office of the Secretary of the Territory, within twenty days after his election as provided in the first section of this act.

- SEC. 3. Said printer shall print the laws and journals and shall What to print. do all the incidental printing of the two houses of the Legislative Assembly, unless otherwise ordered, as provided by the first section.
- SEC. 4. It shall be the duty of the printer'so elected, to compare the proof sheet of the laws and resolutions with the originals on file His duty. in the office of the Secretary of the Territory, and for that purpose the said printer shall at all reasonable times have access to the records in said office.

SEC. 5. The said printer shall forthwith, as soon as may be, after the close of each session of the Legislative Assembly, print the laws in a newspaper printed at Madison, and forward fifteen To print laws in newspaper. copies thereof to the clerks of each organized county in the Territory; which laws thus published, shall be prima facia evidence thereof in all courts whatever.

Compensation

SEC. 6. The said printer so elected shall receive such compensation as shall be from time to time established by law.

APPROVED, February 22nd, 1845.

AN ACT amending an act entitled "An act regulating taverns and groceries."

Be it enacted by the Council and House of Representatives of the Territory of Wisconsin:

SECTION 1. That the forfeitures mentioned in the seventh and Forfeitures to be recovered in action of thirteenth sections of the act of which this act is amendatory, may debt. be prosecuted for and recovered in the name of the United States, in an action of debt, before any justice of the peace of the county in which the offence shall be committed.

It shall be the duty of the Board of Supervisors of Duties of the SEC. 2. the Boards of Enpervisors & every town, and the Board of Commissioners of every county, to Commiss'ers. prosecute in the name of the United States aforesaid, all persons in their respective towns and counties, who may become liable to such forfeitures; and any person may also make complaint and institute such prosecution.

All moneys recovered for such forfeitures, and all moneys received for licenses, in accordance with the act to which this act is amendatory, shall be paid into the treasury of the town where it was so received or recovered, in those counties where the Forfeitur's ap- town system of government has been adopted, and in all other propriated for counties, into the county treasury for county purposes, all of said money shall be appropriated exclusively for the use of common schools in those counties under the town system of government, and shall be distributed in the same manner as other money raised by law for that purpose,
