An Act to appropriate to the County of Crawford the sum therein named. Chap 16.

*THE People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. That there be and hereby is appropriated to the county of Crawford, the sum of one hundred and seventy-two dollars and seventy-six cents, in full for Auditor's warrant number eighty-five, for nine dollars and nineteen cents, dated June 27th, 1844:

For Auditor's warrants number eighty-six, for twenty-eight dollars and fifty-seven cents, dated June 27th, 1844: Auditor's warrant.

And territorial scrip number twenty-seven, for twenty dollars dated February 19, 1842:

Territorial scrip number one hundred and seventeen, for fifty dollars, dated February nineteen, 1842: Ter. scrip.

Territorial scrip number one hundred and seventy, for fifty-two dollars, dated February 19th, 1842.

Territorial scrip number three hundred and five, for five dollars, dated February 19th, 1842:

And territorial scrip number five hundred and twenty-seven, for ten dollars, dated February 19th, 1842, to be drawn from the treasury on the surrender of the said scrip and warrants to the auditor of the state.

An Act to pay George E. Graves the several sums therein named. Chap 17.

*THE People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. There shall be appropriated and paid out of any money in the state treasury to George E. Graves, late sheriff of the county of Milwaukee, viz: Appropriation to G. E. Graves.

The sum of one hundred and thirteen dollars for safe keeping and maintaining Frederick Prusser, a convict sentenced to confinement to the state prison by district court of Milwaukee county, F. Prusser.

from October 14th, A. D. 1846, to May 28th, 1847, and for furnishing necessary clothing, bedding, &c., for said convict.

William Snyder.

And the sum of one hundred twenty-two dollars for the safe keeping and maintaining William Snyder, a convict sentenced to confinement in the state's prison by district court of Milwaukee county, from October 14, A. D. 1846, to June 15th, 1847.

R. Johnson.

And the sum of one hundred twenty-one dollars, for the safe keeping and maintaining Richard Johnson, sentenced by the district court, Milwaukee county, from October 14th, 1846, to June 13th, 1847.

F. A. Starkie.

And the further sum of one hundred forty-four dollars and fifty cents, for safe keeping and maintaining Frederick A. Starkie, sentenced to state prison by district court, Milwaukee county, from November 29th, A. D. 1847, to September 10th, 1848.

J. Myers.

And the sum of seventy-nine dollars, for the safe keeping and maintaining John Meyers, a convict sentenced to confinement to the state prison by the district court of Washington county, from April 5th, A. D. 1848, to September 10th, 1848.

D. Bonham.

And the further sum of seventy-nine dollars, for the safe-keeping and maintaining of David Bonham, from April 6th, A. D. 1848, to September 10th, 1848, in pursuance of a law approved March 11th, A. D. 1848.

## Chap 18.

An Act to provide for the laying out a certain road in the counties of Fond du Lac and Winnebago.

*THE People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows :*

SECTION 1. That commissioners be appointed to lay out a state road from Ceresco, in Fond du Lac county, to Oshkosh in Winnebago county, on the most feasible and direct route.

Com'rs appointed.

SEC. 2. That William Starr, of Fond du Lac county, James M. French, of Winnebago county, and John Smith, of Winnebago county, be and the same are hereby appointed and authorized to lay out said road.

SEC. 3. That no expense arising from the laying out of said road shall be a charge upon the state.
