An Act to change the name of the Village of Arena, county of Iowa.

The People of the State of Wisconsin represented in Senate and Assembly do enact as follows :

SECTION 1. The name of the village of Arena, in the county of Iowa, situated on the north-east quarter of the north-east quarter of section number twenty-four, in township number eight, (8) north of range number five, (5) east of the fourth principal meridian, is hereby changed to "Dover," and it shall hereafter be known in law and otherwise by said name.

An Act to appropriate to Volney French the sum therein named.

SECTION 1. There is hereby appropriated to Volney French the sum of forty dollars in full for principal on Territorial Scrip issued June fourth and February nineteenth, A. D. one thousand eight hundred and forty-two by an act to provide for the payment of expenses of the Legislative Assembly, to wit . numbers thirty-eight, seven hundred and sixty, and four hundred and eighty, to be paid out of any money in the treasury not otherwise appropriated on the delivery of said Scrip.

Chap. 183

SECTION 1. There is hereby appropriated out of any money in the treasury not otherwise appropriated to Alexander F. Pratt the sum of six hundred and fifty dollars in full payment for keeping state prisoners confined in the Waukesha county jail, to the first of January, one thousand eight hundred and fifty one and for services rendered and expenses incurred in pursuing and arresting state prisoners who escaped from said jail in the months of November and December one thousand eight hundred and forty nine.

Whitney out of any money in the treasury not otherwise appropriated, the sum of thirty-six dollars, in full for professional services and medicines furnished to Joseph Palmer a state prisoner, confined in the jail in Milwaukee county during the year one thousand eight hundred and fifty.
