that said premises shall be used for the purposes of a light-house, and the necessary fixtures and improvements for its preservation and maintenance; and that when the United States shall cease to use said premises for the purposes herein specified, the same shall revert to the State of Wisconsin for the use of schools.

## Chap. 22.

An Act in relation to the publication of legal notices.

The People of the State of Wisconsin, represented in Senate

and Assembly, do enact as follows:

SECTION 1. That in all cases where any legal notice is required by law to be published in any newspaper in any county in this Sate, and no public newspaper is printed in said county, such notice shall be required to be published in a newspaper printed in an adjoining county, if a newspaper be printed therein.

SEC. 2. That all the laws of this state inconsistent with the foregoing provisions, be, and the same are hereby repealed.

## Chap. 23.

An Act to establish the Emerald Grove Academy.

The People of the State of Wisconsin, represented in Senate

and Assembly, do cnact as follows:

Corporate Powers.

Densmore, Charles C. Cheney, Asa G. Ransom, Russel Cheney, James Silburn, and Benjamin Fowl, and their associates, together with such persons as may hereafter be associated with them, be, and are hereby, created a body corporate and politic, with perpetual succession, to be styled by the name and title of the Emerald Grove Academy, by which name they and their successors shall be ever known, and shall have power to sue and be sued, to contract and be contracted with, plead and be impleaded, defend and be defended in all courts of law and



equity; said corporation shall have a common seal, and shall have power to acquire, purchase, receive, possess, hold and enjoy property, real and personal, and to sell and convey the same, rent, or otherwise lawfully dispose of at pleasure.

- SEC. 2. The stock of said company shall be divided into stock transferashares of twenty-five dollars each, which shall be deemed per-ble. sonal property, and shall be transferable on the books of said corporation in such manner as shall be directed by the by-laws of said corporation.
- SEC. 3. Any three of the above named persons shall have power to call a meeting of said association, by giving ten days Notice of meetnotice thereof by posting up notices in at least three public ing. places in the said village of Emerald Grove, where said corporation is hereby located.
- SEC. 4. At the first legally notified meeting, the stockholders shall have power to elect by ballot nine Trustees, three of whom shall be elected for one year, three for two years and three for three years, and after the first election three Trus-Trustees, how tees may be elected annually: Provided, always, That all elected. Trustees shall hold their offices until others are elected in their place.

SEC. 5. At all elections and meetings of the company each stockholder shall be entitled to one vote for each share of stock owned by him.

- SEC. 6. The Trustees shall have power—First: to elect from their number a President, Secretary and Treasurer, also to elect all other officers of the corporation. Second: To call special meetings of the stockholders to fill vacancies in the board of Trustees. Third: To sell, lease, mortgage, or otherwise dispose of any real or personal property of said corporation, in such manner as shall be directed by the stockholders, also to erect and keep in repair all necessary buildings for the use of said corporation. Fourth: To employ suitable teachers, Power of Trusand prescribe and direct the course of study and discipline to be observed in said academy. Fifth: To prescribe the duties and fix the salaries of all the officers of said corporation, and remove. or suspend them from office for incapacity, immoral conduct, or misbehavior in office, and to appoint others in their places. Sixth: To make all rules, regulations, and by-laws, necessary and proper to carry into effect the powers herein granted, and not inconsistent with the constitution and laws of this State.
- Sec. 7. No religious test or qualification shall be required of any Trustee or officer of said corporation, nor of any student of said institution.

This act may be amended or altered by any future legislature.

## Chap. 24.

Foundation.

An Act to incorporate Brockway College.

The People of the State of Wisconsin, represented in Senate

and Assembly, do enact as follows:

Section 1. David P. Mapes, Ezra L. Northrup, Alvan E. Bovay, Warren Chase, John S. Horner, Jedediah Bowen, Almon Osborn, Asa Kinney, Edwin Lockwood, Dana F. Shepard, Alexander B. Beardsley, William S. Brockway, Edward L. Runnals, William Starr, and the President of the Collegiate Faculty for the time being, and their successors, shall be, and they are hereby created, a body politic and corporate, to be styled The Board of Trustees of Brockway College, to remain in perpetual succession; the design and purpose of the said Corporation being, and the same is hereby declared to be, to found, establish and maintain, at Ripon, in the County of Fond du Lac, an Institution of Learning of the highest order, embracing also a department for preparatory instruction.

SEC. 2. There shall be fourteen Trustees of said Corporation, and when a Collegiate Faculty shall have been duly chosen and organized, as hereinafter provided, the President thereof shall be ex-officio, the fifteenth Trustee and President of the Board. The Board shall hold its first meeting at Ripon within three months after the passage of this act, and a majority of its members shall in all cases constitute a quorum for the transaction of business. At the first meeting the Trustees shall be di-Trustees term of vided by lot into three classes; the first and second classes to

consist of five members each, the third class of four members. They shall then appoint an annual meeting, the first, to be held within one year thereafter, at which time the office of the first class shall expire, and the office of each class shall expire annually thereafter in rotation forever.

Location.

SEC. 3. The buildings of this Institution shall be located on "out lot No. 4," in the village of Ripon, as the same is laid down and described on a certain map entitled "Plan of the village of Ripon," and recorded in the office of the Register of Deeds for the County of Fond du Lac.
