

Chapter 99.*Published May 21st, 1858.*

AN ACT to amend chapter 116 of the Revised Statutes.

*The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows :*Amended by
adding a pro-
viso.

SECTION 1. The twenty-first section of said act is hereby amended by adding at the end of said section the following: "*Provided*, That in all actions arising under the provisions of this act against boats and vessels navigating the inland waters of this State exclusively, shall be summoned within three months after the cause of action shall have accrued, and not after that period."

AN ACT to authorize the Judge of the Eighth Judicial Circuit Court to hold special terms.

*The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows :*To hold at
least for spé-
cial terms.

SECTION 1. The Judge of the eighth judicial circuit court of this State shall hold at least four special terms in said circuit in each year for the trial of issues of law, for the hearing and trial of cases without a jury, for the hearing of motions, and the transacting of any and all business that may be done at a regular term, except the trial of issues of fact by a jury, at such time and place as the judge of said circuit shall designate. The said judge shall immediately designate and publish in some newspaper published in said circuit, the times and places of holding said terms; and when so designated, they shall not again be changed within two years, and

at such terms the issues of law and motions and all other business that may be transacted thereat pending in any and every county in said circuit may be heard and disposed of with the same force and effect as it may now be heard and disposed of in the county in which the causes or matters are pending, and when the matters and causes are pending in other counties in the circuit different from the county in which the special term is held, the clerk of the court shall certify the orders and papers to the clerk of the circuit court of the county where the same is pending, and the papers shall be filed and entered by the clerk of the court of the county where the cause or matter is pending in the same manner as if the cause or matter had been heard or directed by the circuit court at a term thereof held in that county.

SEC. 2. This act shall immediately upon its passage be published by the State Printer, and when so published shall be in force and take effect.

AN ACT to amend an act entitled "An Act to increase the jurisdiction of the county courts of the counties of Douglass, La Pointe and St. Croix," approved March 6th, 1857.

The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. The county court of St. Croix county shall have and exercise the same powers and jurisdiction within said county in all civil matters as is now by law had and exercised by the circuit court of said county when the amount in controversy shall not exceed the sum of five thousand dollars.

SEC. 2. This act shall be in force and take effect from and after its passage.
