

street, in the sixth ward of said city ; and to pay for the construction of said bridges, or the rebuilding of the same, at any time thereafter. The common council shall levy a tax upon all the taxable property in said city, sufficient to raise the amount of money necessary for that purpose ; which tax shall be levied and collected at the same time, and in the same manner, as other city taxes are levied and collected by law. When the common council shall determine to construct said bridges, or either of them, the plan and specifications for the same shall be made, and the work let by contract, in the same manner as other city work is now required to be done by law. Said bridges shall be free, and constructed in such manner as the common council may determine, and shall be under control of the city, in the same manner as other bridges across the Milwaukee river in said city.

## CHAPTER 258.

[Published April 18, 1860.]

AN ACT to amend an act to consolidate the several school districts in the city of Fond du Lac, approved February 24, 1859.

*The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. That the whole of section nineteen, of said act, be and the same is hereby amended, so as to read as follows : " The said board is hereby authorized to appoint a district treasurer, and it shall be their duty to require a good and sufficient bond for an amount that will cover the sum likely to come into his hands as treasurer of said school district. All moneys to be raised by virtue of this act, and all which said district may be entitled to receive, by virtue of any law of this State, shall be paid to said treasurer, who, together with the sureties of his official bond, shall be accountable therefor to said board of education ; and all funds received by him, belonging to said district, shall be placed to the credit of said board of education, and shall be paid out only upon

their orders, regularly drawn, signed by their president, and attested by their clerk.

CHAPTER 259.

[Published April 19, 1860.]

*The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

AN ACT to provide for laying out a State road from Ashland to Chippewa Falls.

SECTION 1. Martin Beaser, Albert C. Stontz and Rodman Palmer are hereby appointed commissioners to lay out and establish a State road from Ashland, in the county of La Pointe, to Chippewa Falls, in the county of Chippewa. Commissioners to lay out road.

SEC. 2. The said commissioners shall receive, for laying out said road, only such compensation for their services, from the counties through which said road shall pass, as the supervisors of said counties shall deem just and reasonable: *Provided*, that no money shall be paid out of the State treasury therefor, and the State shall not be liable for any expense authorized by this act. Compensation Proviso.

SEC. 3. This act shall take effect and be in force from and after its passage.
