

CHAPTER 297.

[Published April 19, 1861.]

AN ACT to attach the territory hereinafter named to the town of Mount Pleasant, in the county of Racine, and to repeal Chapter 160 of the General Laws of 1861, entitled "An act for the organization of the town of Sagetown, in the county of Racine.

The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows :

Territory attached.

SECTION 1. All that district of country included and embraced within the following limits and boundaries in township No. three of range twenty-three east, in the county of Racine and state of Wisconsin, to wit: The north half of section twenty-one, the north-east quarter of section No. twenty, the east half of section No. seventeen, the east half of section No. eight, the south-east quarter of section No. five, and the south half of fractional section No. four, being the territory detached from the city of Racine, by the judgment of the supreme court, is hereby attached to the town of Mount Pleasant, in said county of Racine, and shall compose a part of the second assembly district in said county.

Repeal.

SECTION 2. Chapter 160 of the general laws of 1861, entitled "An act for the organization of the town of Sagetown, in the county of Racine," approved March 30th, 1861, is hereby repealed.

SECTION 3. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 298.

AN ACT to amend Chapter 81 of the Laws of 1861, entitled "An act for the relief of Racine county."

The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows :

Amendment.

SECTION 1. Section two of chapter thirty-one of the laws of 1861, entitled "An act for the relief of

Racine county," is hereby amended by striking out of section two of said act hereby amended, the words "three months after the passage of this act," where said words occur in said section.

SECTION 2. This act shall take effect and be in force from and [after] its passage and publication.

CHAPTER 299.

AN ACT to amend Section 19 of Chapter 9 of an act entitled "An act to incorporate the city of La Crosse," approved March 14, 1856.

The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Section 19 of chapter 9 of an act to Amendments. incorporate the city of La Crosse, approved March 14, 1856, is hereby amended by inserting after the word "railroad" where it first occurs in said section, the words "plank, turnpike, dirt or gravel road."

SECTION 2. This act shall take effect and be in force from and after its passage.

CHAPTER 300.

AN ACT to extend the time for the sale of lands for unpaid taxes for the year A. D. 1860, in the city and county of La Crosse.

The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. The time for the sale of lands as now Time extended to
Sept. 9, 1861. provided by law for unpaid taxes, interest and charges upon said lands for the year A. D. 1860, in the city and county of La Crosse, is hereby extended to the second Monday in September, A. D. 1861, and the
