

CHAPTER 47.

[Published February 28, 1861.]

AN ACT to amend Section two of Chapter seven of the Revised Statutes, entitled "Of General and Special Elections, of the manner of conducting the same, and of the canvass."

The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows :

SECTION 1. Section two of chapter seven of the revised statutes, is hereby amended by adding thereto the following words : "Nor shall any person be deemed to have gained a residence in any town or ward in this state, so as to entitle him to vote at any election in such town or ward, by remaining in such town or ward as a pauper, supported by the town or county in which he shall be living at the time of such election ; and no person shall be deemed to have lost his residence in any town or ward by remaining in any other town or ward as such pauper."

Defining place of residence.

SECTION 2. This act shall take effect and be in force from and after its passage.

CHAPTER 48.

[Published February 28, 1861.]

AN ACT to extend the time for the collection of school and village Taxes in the village of Sheboygan Falls, in the county of Sheboygan.

The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows :

SECTION 1. The time for the collection of school and village taxes in the village of Sheboygan Falls in the county of Sheboygan, for the year 1860, is hereby extended to the first day of April, 1861.

Time extended to 1st of April.

SECTION 2. The treasurer of said village shall have the same power and authority to collect the taxes contained in said village tax roll, after as before such extension of time for the collection of said taxes : *pro-*

vided, on all taxes paid or tendered at the office of such treasurer prior to the tenth day of March, 1861, the said treasurer shall remit to the person so paying or tendering, three-fifths of the amount included in said lists as his fees for collecting such tax so paid.

SECTION 3. This act shall take effect and be in force on and after its passage.

CHAPTER 49.

AN ACT to amend an act entitled "An act to consolidate and amend the act to incorporate the city of Milwaukee, and the several acts amendatory thereof, approved February 20th, 1852, and to amend the several acts amendatory thereof."

The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. An act to amend an act entitled "An act to consolidate and amend the act to incorporate the city of Milwaukee, and the several acts amendatory thereof, approved February 20th, 1852, and to amend the several acts amendatory thereof," is hereby amended as follows, to-wit: The election of city and ward officers for the city of Milwaukee, for the year 1861, which is now required by law to be held on the first Tuesday of March, is hereby postponed to the first Tuesday of April, and all the elective officers of said city now in office, shall hold their respective offices until their successors shall be elected and qualified as required by the laws regulating said city.

SECTION 2. This act shall take effect from and after its passage.
