CHAPTER 125.

AN ACT to legalize the official acts of J. H. Duester, as justice of the peace in the county of Milwaukee.

CHAPTER 128.

AN ACT to amend section 2 of chapter 62 of the general laws of 1860, entitled "an act concerning the terms of court in the 4th judicial circuit."

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :

SECTION 1. Section two of chapter 62 of the general laws of 1860, entitled "an act concerning the terms

of court in the fourth judicial circuit," is hereby amended by substituting the word "May" in lieu of the word "June," where it occurs in the second line of said section.

SECTION 2. This act shall take effect and be in force from and after its passage.

CHAPTER 129.

[Published March 27, 1862.]

AN ACT to amend chapter 28 of the revised statutes, entitled "of [the] school and university lands."

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Section sixty-one of chapter 28 of the revised statutes, entitled "of the school and university lands," is hereby amended [so as] to read as follows: "Whenever any school, university or swamp lands shall have been forfeited for the non-payment of either principal or interest, and shall have remained forfeited for three months, the school land commissioners shall advertise such land for sale, by publication of notices thereof for six weeks, in a newspaper published in the county where the lands lie, if there be any, and if not, then in some newspaper published nearest thereto. Such sale shall be made, either in the county where the lands lie, or at the capitol in Madison, on some day not less than three months, nor more than six months, after the first publication of said notice. The notice shall specify the time and place of sale, a description of the lands to be sold, the amount due thereon, and the names of the persons to whom the certificates of sale were issued. And it shall be the further duty of the said commissioners to give notice of the sale of such forfeited lands, by advertising in the newspaper published in Madison, in which the laws are officially published, for six weeks successively, the time when and
