CHAPTER 339.

AN ACT relating to the sale of lands for the unpaid taxes of the year 1861.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Sale to commence Sept. 2.

SECTION 1. The county treasurer of each county, and the city treasurer of each city who is authorized by the charter of such city to sell lands for unpaid taxes, shall, on the first Tuesday of September next, proceed to sell all lands in his county or city, on which the taxes for the year one thousand eight hundred and sixty-one shall at that time remain unpaid, and shall give notice of such sale and conduct the same in all respects as is now required by law: *provided*, that in all cases where a statement of the lands on which the taxes, interest and charges were unpaid for the year 1861, with a notice of sale of such lands, was by order

of any such treasurer published in any of the months of March, April and May last, in the manner required by law, no further or other statement of such lands shall be published; but in such case such treasurer shall cause a notice to be published in the paper in which such statement was published, to the effect that he will, on the first Tuesday of September next, proceed to sell all lands in such statement contained, on which the taxes, interest and charges shall at that time remain unpaid. Such notice shall definitely refer to such statement, and shall mention the paper in which and the time when the same was published, and shall be published four weeks prior to the day of sale, and proof of the publication thereof shall be filed in the proper office.

SECTION 2. In all cases where the statement mentioned in the preceding section, was published during any of months of March, April and May last, and proof of such publication has not been filed in the proper office, such proof shall be made and filed with the proof of the publication of the notice in the preceding section required. Proof of publication.

SECTION 3. So much of section one of chapter two hundred and seventy-six of the general laws of the year 1862, as is comprised in the following words, to wit: "exclusive of interest and advertising fees," is hereby repealed. Repeal.

SECTION 4. This act shall be published and shall take effect immediately; and the secretary of state shall transmit printed copies thereof to the several county treasurers. Act to be published and copies sent to treasurers.
