

the money arising from such tax shall be applied to no other purpose whatever. Money shall be paid from the treasury of the board, on future appropriations, only upon certificate of its president and clerk, and no order on the treasury nor other evidence of debt shall hereafter be issued upon the allowance of claims.

SECTION 10. Any provision of law heretofore passed, prohibiting the common council from levying a tax to pay judgments against the city, is hereby repealed, and the former law restored. <sup>Repeal and restoration.</sup>

SECTION 11. Section four of chapter six of the city charter, and section three of the act amendatory thereof, approved February 1st, 1858, and all acts and parts of acts, so far as they conflict with this act, are hereby repealed. <sup>Repeal.</sup>

SECTION 12. This act shall be in force from and after its passage and publication.

## CHAPTER 380.

[Published June 24, 1862.]

AN ACT for the flowing of lands in Juneau county, for the purpose of cultivating [cultivating] cranberries.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. That the county board of supervisors of Juneau county are hereby empowered to make all such rules and regulations for the flowage and drainage of the swamp and overflowed lands in said county, as in the opinion of said board may be necessary for the encouragement and promotion of the cultivation of said lands, so far as the public interest and welfare of the county may require. <sup>Authority to supervisors.</sup>

SECTION 2. No private property shall be injured in consequence of the acts of the county board of supervisors, authorized by section one of this act, without, first, compensation shall be made therefor. <sup>Compensation for damages.</sup>

SECTION 3. The compensation aforesaid shall be de- <sup>How determined.</sup>

terminated by commissioners appointed by said board of county supervisors.

SECTION 4. This act shall take effect from and after its passage and publication.

## CHAPTER 381.

[Published June 24, 1862.]

AN ACT for the relief the Monroe county agricultural society.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :*

Order on treasurer.

SECTION 1. The secretary of state is hereby authorized and directed to issue an order upon the state treasurer, in favor of the Monroe county agricultural and manufacturing society, pursuant to section five of chapter 53 of the general laws of 1858, in the same manner as though the annual report of said society had been received on the first day of February, 1862: *provided*, said report be on file in the office of the secretary of state at the time of the passage of this act.

SECTION 2. This act shall take effect and be in force from and after its passage.

AN ACT to authorize the secretary of state to audit certain accounts.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :*
