

## CHAPTER 47.

[Published April 11, 1866.]

AN ACT to amend sections 2, 5 and 6 of chapter 364 of the general laws of 1866, entitled "an act for the encouragement and protection of the wool-growing interest in this state."

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :*

SECTION 1. Section two (2) of said chapter is hereby amended, so as to read as follows: "Section 2. Any person claiming such reward, shall produce the scalp or scalps of the wolf or wolves so killed, with the ears entire, to the clerk of the board of supervisors of the county within which such wolf or wolves were killed, and such clerk shall administer to the person producing such scalp or scalps as aforesaid, the following oath or affirmation: 'You do solemnly swear, (or affirm, as the case may be,) that the scalp (or scalps) now produced by you, is the scalp (or are the scalps) of a wolf (or wolves, as the case may be,) taken in the county of (naming the county) by you, within twenty days last past, and that you have not spared the life of any wolf within your power to kill;' which oath or affirmation shall be taken by the clerk in writing, and subscribed by the person producing the scalp or scalps."

Scalp and ears to be delivered to clerk of court.

Oath as to killing, &c.

SECTION 2. Section 5 of said chapter is hereby amended, so as to read as follows: "Section 5. If any person shall be guilty of obtaining from the clerk of the board of supervisors of any county in this state, any such certificate as hereinbefore provided for, by any false or fraudulent representations or practices, he shall be deemed guilty of a misdemeanor, and upon conviction thereof shall be punished by a fine not exceeding one hundred dollars, and by imprisonment in the county jail for not more than one year."

Penalty.

SECTION 3. Section 6 of said chapter is hereby amended, so as to read as follows: "Section 6. If any clerk of the board of supervisors of any county, who shall be applied to for a certificate under the provisions of the preceding sections of this act, shall willfully or knowingly give a false certificate, such clerk shall be deemed guilty of misdemeanor, and on conviction thereof shall be punished by a fine not exceeding one hundred

red dollars, or by imprisonment in the county jail for not more than one year.”

SECTION 4. This act shall take effect and be in force from and after its passage and publication.

## CHAPTER 48.

[Published April 12, 1866.]

AN ACT in relation to state property, and purchases by the state.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

Board to order sale of state property not longer in use to the state.

SECTION 1. The governor, secretary of state and state treasurer are hereby constituted a board of inspectors, to examine, at the request of the superintendent of public property, or order of the governor, any chattel property of the state in the hands of said superintendent, which is not in use at any time, and direct it to be sold or otherwise disposed of, in such manner as said board may deem to be for the best interests of the state.

How sales to be made.

SECTION 2. Sales under the provisions of this act, may be made at public auction, or otherwise, as the board of inspectors shall direct, and when at public auction, notice of sale shall be given by daily publication for at least ten days in the state paper, and sale made to the highest bidder for cash.

Proceeds to be paid to state treasurer, &c.

SECTION 3. The proceeds of any and all sales authorized by this act, shall be paid over to the state treasurer, after deducting all necessary expenses of sale, by the superintendent of public property, and the state treasurer's receipt, countersigned by the secretary of state, together with a copy of the order of sale made by said inspectors, and an account of sale, with necessary expenses of sale deducted, approved by said board, shall be a sufficient voucher in [the] hands of said superintendent, for the property so sold. The order of the inspectors shall be a good voucher for property otherwise disposed of.
