

## CHAPTER 82.

[Published March 9, 1868.]

AN ACT to authorize the state superintendent of public instruction to apportion school moneys to the towns of Vinland, Clayton and Neenah, in the county of Winnebago.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. The state superintendent of public instruction in apportioning the income of the school fund in the year 1868, shall apportion to the towns of Vinland, Clayton and Neenah, in the county of Winnebago, the amount the said towns would have been entitled to if joint school district No. one therein had maintained a school for five months during the year ending August 31st, 1867. Shall apportion moneys.

SECTION 2. The town clerks of the said towns of Vinland, Clayton and Neenah shall, during the year 1868, apportion to joint district No. one thereof the full sum of money said district would have been entitled to, if the report of the clerk of said district for the year 1867 had shown that a school had been maintained therein, by a qualified teacher, for five months during the year covered by such report. Duty of town clerks.

SECTION 3. This act shall take effect and be in force from and after its passage and publication.

## CHAPTER 83.

[Published March 9, 1868.]

AN ACT to amend section one, chapter 32, of the revised statutes, entitled "of the public health."

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. The words "justices of the peace," in Amended. the first line of section one of chapter thirty-two of the

revised statutes are hereby stricken out, and the said section is amended by inserting in lieu thereof the words "board of supervisors."

SECTION 2. This act shall take effect from and after its passage and publication.

## CHAPTER 84.

[Published March 9, 1868.]

AN ACT to declare the Shioc river and its tributaries a public highway for driving or running logs, and to regulate the same.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

Declared navigable.

SECTION 1. The Shioc river and its tributaries are hereby declared to be navigable streams for the purpose of driving logs and timber from the head waters of said river and its tributaries to its mouth where it enters into the Wolf river, and it shall be lawful for any person or persons to drive logs and timber upon said Shioc river and its tributaries, subject to the conditions and limitations hereinafter provided.

Obstructions to be removed.

SECTION 2. It shall not be lawful for any person or persons to obstruct the said Shioc river or its tributaries with any logs, timber or other materials, so as to obstruct the free navigation thereof for logs and timber, and in case any person or persons owning logs or timber, or having the same in charge, shall suffer or permit the same to remain at any place or places in said streams so as to obstruct the same for the free passage of logs or timber belonging to other parties, it shall be lawful for such other parties owning such logs or timber, or the person or persons having the same in charge, to remove such obstructions by driving the said logs and timber down any or either of said streams to some safe and secure place in said streams or in the Wolf river.

Compensation for removing obstructions.

SECTION 3. The person or persons or company, removing any such obstruction in the manner provided
