Bounty for
wolves poi-
soned.

SECTION 3. Any person or persons, in this state, who shall present to the county clerk any wolf scalp, or scalps, with the ears entire, shall be entitled to all the bounty, whether the wolf from which such scalp was taken has been killed by poison or otherwise.

SECTION 4. Within three days after the said twentieth day of December, the person or persons so having put out such baits or banes, shall take up and effectually destroy the same which shall remain. A

Penalty for
neglect.

failure to destroy, as aforesaid, as well as a failure to comply with section two of this act, shall subject such person, or persons, to whatever damages may be sustained by the neglect, and also a fine of not less than five dollars, all to be recovered before a justice of the peace of the county, in the same manner as other damages and fines are collected.

Duty of chair-
man or clerk
of town board.

SECTION 5. It is hereby made the duty of the chairman or clerk of the town board of each town in this state to read publicly the foregoing chapter at the time and place of reading the report and voting appropriations at the town election in April, in each year.

SECTION 6. This act shall take effect and be in force from and after its passage and publication.

AN ACT to repeal chapter three hundred and forty-nine (349) of the private and local laws of 1871, entitled, "an act to amend section three (3), of chapter two-hundred and forty-nine (249) of the private and local laws of 1870, entitled, 'an act to incorporate the Silver Glance Mining Company.'"

The people of the state of Wisconsin represented in Senate and Assembly, do enact as follows:

SECTION 1. Chapter three hundred and forty-nine (349) of the private and local laws of 1871, entitled "An act to amend section three (3), of chapter two hundred and forty-nine (249) of the private and local laws of 1870, entitled, 'an act to incorporate the

Silver Glance Mining Company," is hereby repealed.

SECTION 2. This act shall take effect and be in force from and after its passage.

CHAPTER 21.

Straw on May 19, 1875.

AN ACT to amend an act entitled, "An act to amend section ten, of chapter one hundred and thirty-two, of the Revised Statutes of 1858, relating to verdicts and exceptions."

The people of the state of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Section one, of chapter one hundred and ninety-four, of the laws of 1874, is hereby amended so as to read as follows: Section ten, of chapter one hundred and thirty-two, of the Revised Statutes, is hereby amended so as to read as follows: A general verdict is one by which the jury pronounce generally upon all or any of the issues, either in favor of the plaintiff or defendant. A special verdict is that by which the jury find the facts only, leaving the judgment to the court. In all civil cases the court shall, at the request of any party, direct the jury to find a special verdict. *Provided*, That such request be made at the close of the testimony and before any argument to the jury. Such special verdict shall be in writing, and shall be filed with the clerk and entered upon the minutes.
