

Preparation of reports for publication.

the commissioners of public printing, whose duty it shall be to strike therefrom all parts not actually necessary, in their judgment, to be printed for the information of the people as to public affairs, and to order the publication of the remainder in condensed form, as said commissioners may determine and prescribe. The part so stricken out shall first be copied in a book by the secretary of state, and then returned to the respective offices from which they originated; and shall there be recorded, and shall at all reasonable times be open for examination by the public. Section 334. In preparing said reports for the state printer, said commissioners shall give all items of receipts and disbursements in full and in detail, and such items shall be printed in solid brier, and otherwise in the most condensed and economical manner practicable.

SECTION 2. All acts and parts of acts conflicting with the provisions of this act are hereby repealed.

SECTION 3. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 170.

AN ACT to change the boundaries of certain towns in Lincoln county, and to organize a new town.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :

Ackley.

SECTION 1. Townships number thirty-one, thirty-two, thirty-three, thirty-four, thirty-five, thirty-six, thirty-seven, thirty-eight, thirty-nine, forty, forty-one, forty-two and forty-three north, of range number ten east, and the east half of townships thirty-one and thirty-two north, of range nine east, shall constitute and be known as the town of Ackley. The town of Ackley shall hold its first meeting at the school house, on the southwest corner of section thirty, town thirty-two, range ten east, known as the Lloyd district, on the first Tuesday of April, 1879, and shall there and then fully organize pursuant to the general laws of this state. No notice of such first meeting of the town of Ackley shall be required, except that given by the passage of this act.

Town meeting.

SECTION 2. The east half of township thirty-one north, of range seven east; township thirty-one north, of range eight east; the west half of township thirty-one north, of range nine east; township thirty-two north, of range eight east; the west half of township thirty-two north, of range nine east; township thirty-three north, of range nine east; the east half of township thirty-four north, of range nine east; the east half of township thirty-five north, of range nine east; the east half of township thirty-six north, of range nine east; the east half of township thirty-seven north, of range nine east; townships thirty-eight, thirty-nine, forty, forty-one, forty-two and forty-three north, of range nine east, and sections twenty-five and thirty-six of township thirty-two north, of range seven east, shall constitute and be known as the town of Pine River.

SECTION 3. Townships thirty-one, thirty-two, thirty-three, thirty-four, thirty-five and thirty-six, north of ranges four and five east, shall constitute and be known as the town of Corning.

SECTION 4. The west half of township thirty-two north of range six east; townships thirty-three, thirty-four, thirty-five and thirty-six, north of range six east; townships thirty-seven, thirty-eight and thirty-nine, north of ranges four, five and six east, and township forty, north of ranges four and five east; township forty-one, north of ranges two, three, four and five east; and townships forty-two, forty-three, forty-four, forty-five, forty-six and also fractional part of township forty-seven, north of range two east; and the west half of township thirty-five, north of range seven east, shall constitute and be known as the town of Rock Falls.

SECTION 5. All the remaining territory embraced within the county of Lincoln and not enumerated in the above subdivision of towns shall constitute and be known as the town of Jenny.

SECTION 6. This act shall take effect and be in force from and after its passage and publication.
