

worth county, two hundred copies of said Simmons' new digest of Wisconsin reports, at six dollars per copy; provided, that said digest shall contain in one volume a complete digest of volumes forty-four to sixty-one inclusive, of the official reports of the decisions of the Wisconsin supreme court, and under the same series of titles, a complete condensed digest of all the decisions of said court published in previous reports up to and inclusive of volume forty-three; and that said copies shall be of as good material, as well printed, and bound in good, substantial law binding, as his previous volumes of Wisconsin digests, and uniform therewith.

How distributed.

SECTION 2. The copies so purchased shall be delivered to the secretary of state, at Madison, within two months after the publication thereof, shall be completed, and shall be by him distributed and disposed of in the same manner as is provided by law for the distribution of the reports of the supreme court.

When to be paid for.

SECTION 3. Upon receipt of said two hundred copies of said digest, of such materials, and so printed and bound as provided by section 1, of this act, the account therefor, at the price aforesaid, shall be audited by the secretary of state and paid by the state treasurer, upon the warrant of said secretary of state, out of any money in the treasury not otherwise appropriated.

SECTION 4. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 429.

AN ACT to authorize the common council of the city of Milwaukee to allow the claim of James Hoye for paving Erie street.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :

Claim of James Hoye allowed.

SECTION 1. The common council of the city of Milwaukee is hereby authorized and empowered

to allow, and the mayor and city clerk are authorized and directed to sign and the comptroller to countersign, a city order in payment of the claim of James Hoye, when so allowed against said city, for the balance and sum of twelve hundred and seven dollars and twenty-six cents, for grading and paving Erie street from Broadway to Jefferson street, in the third ward of said city, in 1880, under the verbal employment and contract of the board of public works of said city with him therefor, after the determination of his written contract with the city therefor; provided, that the sum so allowed shall be charged to the ward fund of said third ward.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 430.

AN ACT to provide for the erection and maintenance of water works and lay water pipes in villages.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Section 892, of the revised statutes, is hereby amended, by adding thereto the following subdivision: 29. To construct and maintain water works for the supply of water to the inhabitants of the village, with necessary pumping machinery, buildings, reservoirs, mains, pipes and other convenient appliances; and to regulate the mode of construction, the manner of making connections therewith, the rent for the use of water, and all matters necessary to operating such system; and the whole or a part of the cost of laying any street mains may be assessed upon the adjoining property in any street, or portion of street, in which the same may be laid, proportioned to frontage, upon the petition of a majority of the owners of property fronting upon such street or portion thereof, including the owners of at least
