

bond for good cause shown. The said county judge shall examine the said accounts so rendered and shall audit the same, and shall examine the manner of the investment of said trust fund, and the securities so held shall be submitted to said judge.

SECTION 3. Gifts, bequests and trusts of property made for the purposes specified in section 1, of this act, shall be exempt from taxation and from the operation of all laws mortmain and laws against perpetuities and accumulations. Exempt from taxation.

SECTION 4. This law shall take effect from and after its passage and publication.

## CHAPTER 389.

AN ACT to provide for a general law for the incorporation of cities.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. The justices of the supreme court are hereby authorized to appoint three competent persons, one of whom shall be the attorney general, to draft a bill for a general law for the incorporation of cities. Justices of supreme court to appoint three persons to draft bill for incorporation of cities.

SECTION 2. The persons so appointed shall enter upon their work as soon as practicable, and when the work is completed shall report the same to the next succeeding legislature. Duty imposed.

SECTION 3. The persons so appointed shall receive such compensation for their services as the justices of the supreme court shall deem just and reasonable, to be audited by the secretary of state upon the written allowance of such justices, and paid out of the state treasury out of any money belonging to the general fund not otherwise appropriated; provided, that no more than four hundred dollars shall be audited and allowed to each such person. Compensation.

Vacancy, how filled.

SECTION 4. In case any of the persons so appointed become incapacitated, by reason of sickness or from other cause, to perform their duties under this act, the justices of the supreme court are hereby authorized to appoint a suitable person to take the place of the person so incapacitated.

State printer to do printing on approval of justices.

SECTION 5. It shall be the duty of the state printer to do any and all printing for said persons so appointed, which may necessarily be required by them in the performance of their duties; but all orders for such printing shall first be approved by the justices of the supreme court.

SECTION 6. This act shall take effect and be in force from and after its passage and publication.

## CHAPTER 390.

AN ACT to amend section 1365, of chapter 54, revised statutes, relative to drains and water courses.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

Amending section 1365, R. S.

SECTION 1. Section 1365, of the revised statutes, and all acts amendatory thereof are hereby construed as applying to any two adjoining towns, whether the same be wholly in one county, or whether they be in different counties.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.
