CHAPTER 46.

AN ACT to further provide for the safety of factories and public buildings.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Any architect who shall draw plans for or superintend the erection of any school-house, church, hall, factory or hotel without providing in said plans the fire escapes and outward swinging doors now required by law, shall be guilty of a misdemeanor, and on conviction thereof shall be fined twenty-five dollars for the first offense and one hundred dollars for each subsequent offense.

Architect drawing plans for, or superintending erection of school house, church, hall, factory or hotel, failing to provide fire escapes, etc., guilty of misdemeanor.

SECTION 2. Any person or persons, body corporate, official or officials, who shall erect or cause to be erected, any building named in this act without providing the fire escapes and outward swinging doors, or who shall neglect to provide the same as required by law, shall be guilty of a misdemeanor, and upon conviction thereof shall be fined one hundred dollars.

Penalty for so erecting buildings without fire escapes.

SECTION 3. All acts or parts of acts conflicting with this law are hereby repealed.

SECTION 4. This act shall be in full force and effect from and after its passage and publication.

CHAPTER 47.

AN ACT to provide for the payment of the debts and obligations of county agricultural societies.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Every county agricultural society in this state which shall have fixed a valuation to

the aggregate of its property, and divided such valuation into equal shares, and issued to its members certificates of stock under the provisions of section 1461, of the revised statutes, may, whenever the cash funds of said society are insufficient to pay the debts and obligations of such society, make an assessment upon all the members of such society sufficient to pay such debts and obligations in the manner herein provided. Such society, at its annual meeting, shall, by resolution, to be entered of record, determine and assess the sum to be paid by all the members thereof, and the time when and the officers to whom the same shall be paid; and the secretary shall immediately notify every member of such society by letter sent to his usual post-office address, of the amount of such assessment and the sum due from him as his share thereof, and the time when and the officer to whom payment thereof is to be made, which time shall be not less than sixty nor more than ninety days. If any member of such society shall neglect or refuse payment of any such assessment for the space of thirty days after the same shall have become due and payable, and after he shall have been notified thereof by the secretary as hereinbefore provided, the stock of such negligent member may be sold by the executive committee of such society at public auction, giving at least thirty days' notice of such sale by posting notices in three conspicuous places in the county where such society is situated. The proceeds of such sale shall be first applied in payment of the assessment called for, and the expense attending the sale, and the residue refunded to the owner thereof; but if the proceeds of such sale shall not be sufficient to pay such assessment and the expense of sale, such delinquent member shall remain liable to the society for such deficiency. Such sale shall entitle the purchaser to all the rights of a member to the extent of the shares so bought. Every assessment hereunder, when collected, shall be paid to the treasurer of such society, and applied to the payment of the debts and obligations for which such assessment was made.

SECTION 2. All acts and parts of acts conflicting with the provisions of this act are hereby repealed.

SECTION 3. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 48.

AN ACT to appropriate a certain sum of money therein named to the Gettysburg battlefield memorial association, and for the erection of monuments on the battlefield of Gettysburg, Pennsylvania, and to defray the expenses of the commission herein provided for.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. There is hereby appropriated to the Gettysburg battlefield memorial association, out of any moneys in the treasury not otherwise appropriated, the sum of one thousand five hundred dollars, to be expended by said association in the purchase of lands of especial interest, on that field, including lands to mark the position of each Wisconsin regiment, and the position of company "G" of Colonel Berdan's first regiment of U. S. sharp-shooters, engaged in the battle of Gettysburg; the construction, fencing and repairs of avenues, drive-ways and pathways, and otherwise improving and preserving the field. The said amount to be paid upon the approval of the governor to the treasurer of the Gettysburg battlefield memorial association, on his order approved by the president, or vice-president of the said association.

Appropriation to Gettysburg battlefield memorial association of \$1,500 for purchase of lands of especial interest, to mark position of each Wisconsin regiment.

SECTION 2. There is hereby appropriated out of any moneys in the treasury not otherwise appropriated, the sum of one thousand dollars each, for the following organizations, viz.: The second, third, fifth, sixth, seventh and twenty-sixth regiments of infantry, and five hundred dollars for company "G" of Colonel Berdan's first regiment of U. S. sharp-shooters, all Wisconsin

Appropriation for purpose of procuring and erecting suitable monuments on battlefield of Gettysburg.
