CHAPTER 126.

AN ACT to amend section 2537, of the revised statutes of the state of Wisconsin, in relation to special venires for jurors.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Relating to special venires for jurors.

SECTION 1. Amend section 2537, of the revised statutes of the state of Wisconsin, so as to read as follows: Section 2537. Whenever at any term of any circuit court, there shall be an entire absence of jurors of the regular panel, whether from an omission to draw and summon the same, or because of a challenge to the panel, or from any other cause, the court may order a special venire to issue and in such order may direct the number to be summoned; immediately on the making of such order, the clerk of the court, in the presence of the judge thereof, shall proceed to draw from the box containing the names of the persons returned as petit jurors for that year, the number of persons specified in such order; thereupon such special venire shall be directed to the sheriff of the county, commanding him to summon the persons so drawn, to appear before said court forthwith or at such time as shall be directed by order of the court; and whenever there shall be a deficiency of jurors of the regular panel, at any time during the term, for any cause whatever, the court may order a sufficient number to be drawn and summoned in the same manner as in this section specified, to supply such deficiency. The names so drawn to serve in such manner as herein' specified, and not held to serve, shall be returned to the box in which are kept the names of such petit jurors for such year, subject to be drawn for any subsequent term of court.

SECTION 2. All acts or parts of acts conflicting with the provisions of this act are hereby repealed.

SECTION 3. This act shall take effect and be in force from and after its passage and pub-

CHAPTER 127.

AN ACT amendatory of and supplementary to chapter 116, of the annotated statutes of Wisconsin, entitled, "Of jurors."

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. All the provisions of section Drawing jurors 2544a to r of the annotated statutes of Wisconformunicipal sin relating to and regulating the manner of the people. drawing petit jurors in certain counties, shall be equally applicable to municipal courts in counties containing a population of over one hundred fifty thousand people. The commissioners provided for in said sections shall, in addition to the list of names furnished to the clerk of the circuit court of such county, furnish to the clerk of the municipal court of such county separate lists of persons to be drawn from the body of the county to serve as petit jurors in such municipal court at the time and times provided in said sections; and such list of names when so made up shall constitute the jury list of such municipal court, from which all petit jurors shall be drawn in the manner prescribed in said section.
