CHAPTER 111.

AN ACT to amend section 84 of the statutes, relating to the determination and publication of the county canvass.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Section 1. Section 84 of the statutes is amended to read: Section 84. They shall then determine the persons who have been, by the greatest number of votes, elected to the several county offices and members of the senate and assembly, when the county constitutes one or more senate or assembly districts, and such determination shall be reduced to writing, certified as correct and attested by their signatures, and be annexed to the statement of votes given for such offices respectively, and filed and recorded with the same. Such statement and determination shall be published in * * * one or more newspapers of the county * * * which the canvassers designate * * .*. If the canvassers decide to have said publication in more than one newspaper in said county, they shall designate at least one professing the political faith of the party which received the highest number of votes at the last general election in said county and at least one professing the political faith of the party which received the next highest number of votes at the last general election. The papers so designated shall be paid by the county.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 112.

AN ACT to appropriate to the state park board money to reimburse it for certain expenditures made necessary by the inadvertent omission in chapter 495, laws of 1907, and making a further appropriation therefor.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. There is appropriated to the state park board a sum not exceeding four hundred and thirty-six dollars and eighty-five cents (\$436.85) out of any moneys in the state treas-

ury not otherwise appropriated to reimburse said park board for expenditures for maps, options, and getting out their annual report, incurred during the fiscal year ending January 1, 1909, such appropriation being made necessary by the inadvertent omission of the word "annually" in section 2 of chapter 495, laws of 1907.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 113.

AN ACT to amend section 1978c of the statutes, relating to insurance of public buildings.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Section 1. Section 1978c of the statutes is amended to read: Section 1978c. 1. In case any buildings or property of the state shall be damaged by fire or tornado, the commissioner of insurance shall within thirty days ascertain and fix the amount of such damage and forthwith file with the state treasurer and the secretary of state a statement of the same.

2. When the amount of loss has been fixed and determined by the commissioner of insurance and certified to the secretary of state, the secretary of state shall issue a warrant in the amount fixed by the insurance commissioner as a transfer of the amount fixed as damages from the "state insurance fund" and credited to the proper fund of the officer, board of control, board of trustees, or other agents in whose control said buildings or property belongs, to be used by said officer, board, or agent for the rebuilding or restoring of the property damaged and to be disbursed by the state treasurer in such manner as other state funds for the use of said officer, board, or agent are paid out, and if at the time of any such award of loss or damage by the commissioner of insurance, there shall not be in the "state insurance fund" an amount equal to such award, * * the secretary of state shall, notwithstanding this fact, draw his warrant payable from the general fund, and the state treasurer shall promptly pay such warrant out of any moneys in his hands in the manner above provided.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.
