CHAPTER 3.

AN ACT to amend sections 111c, 111d, 111e and 111f of the statutes, relating to legislative employees, and making an appropriation.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Sections 111c, 111d, 111e and 111f of the statutes are amended to read: Section 111c. The number, duties and compensation of the subordinate clerks of the senate shall be as follows:

(1) *One general clerk, five dollars a day.*

* * * (2) *One journal clerk, five dollars a day.*

* * * (3) *One assistant journal clerk, five dollars a day.*

* * * (4) *One bookkeeper, five dollars a day.*

* * * (5) *One assistant bookkeeper, five dollars a day.*

* * * (6) *One index clerk, who shall be an expert in card indexing, and who shall prepare the indices, five dollars a day.*

* * * (7) *One * * * engrossing clerk, who shall be an expert stenographer and typewriter, to have charge of the engrossing room, five dollars a day.*

* * * (8) *Eight clerks, who shall be expert in stenography and typewriting, to perform general clerical duties for members and committees, each five dollars a day.*

(9) *Two clerks, who shall be expert proof readers, * * * to serve * * * as revision and enrolling clerks, each five dollars a day.*

* * * (10) ** * * three clerks, who shall be expert in the use of the typewriter, to engross bills, each four dollars a day.*

(11) *One mailing clerk, four dollars a day.*

Section 111d. The number, duties and compensation of the subordinate clerks of the assembly shall be as follows:

(1) The same as provided for the senate, and in addition thereto:

(2) *One clerk for the joint committee on claims, who shall be a stenographer and who shall have a general knowledge of accounts, five dollars a day.*

(3) * * * *One* general clerk, * * * five dollars a day.

(4) Three clerks, who shall be expert in stenography and typewriting, to engross bills and perform general clerical work for members, each * * * *five* dollars a day.

(5) *One* clerk, who shall be expert in the use of the typewriter, to engross bills, *four* dollars a day.

Section 111e. The number, duties and compensation of the subordinates of the sergeant-at-arms of the senate shall be as follows:

(1) One assistant sergeant-at-arms, five dollars a day.

(2) One postmaster, four dollars a day.

(3) One custodian of the document room, who shall perform such duties as may be required by the rules of the body, four dollars a day.

(4) One policeman, three dollars a day.

(5) One night watchman, three dollars a day.

(6) * * * *Two* night laborers, *each* three dollars a day.

(7) * * * *Nine* messengers, each two dollars *and fifty cents* a day.

(8) *One* gallery attendant, *three* dollars a day.

Section 111f. The number, duties and compensation of the subordinates of the sergeant-at-arms of the assembly, shall be as follows:

(1) The same as provided in the senate and in addition thereto:

(2) One assistant document room clerk, three dollars a day.

(3) One post-office messenger, who shall carry and deliver mail for both houses, three dollars a day.

(4) * * * *Five* messengers, each of whom shall be paid two dollars *and fifty cents* a day.

(5) One cloakroom attendant, three dollars per day.

(6) * * * *One* gallery attendant * * *, three dollars per day.

SECTION 2. There is hereby appropriated out of any money in the state treasury not otherwise appropriated a sum sufficient to carry out the provisions of this act.

SECTION 3. This act shall take effect upon passage and publication.
