2. The amount of any certificate referred to in subsection 4 of section 496 shall be paid at any time after the first day of October, out of the general fund of the state treasury, but the whole amount so paid shall not exceed seventy-five thousand dollars in any one year to this class of free high schools and if more is demanded by such districts they shall be paid proportionally.

SECTION 3. This act shall take effect upon passage and publication.

CHAPTER 559.

AN ACT to appropriate to certain persons the amounts therein named, being a repayment of the license fees for pound net licenses issued pursuant to section 4560a—40 of the statutes.

CHAPTER 560.

AN ACT to provide for a joint committee to investigate the system of courts in Wisconsin and to recommend such changes as may be necessary to promote efficiency and economy in the administration of justice, and making an appropriation therefor.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. There is created a joint committee to consist of ten members, two to be appointed by the presiding officer of the senate, three by the presiding officer of the assembly, and three by the governor from a list of ten persons nominated by the president of the State Bar Association. The president of the State Bar Association and the president of the Wisconsin Branch of the American Institute of Criminal Law and Criminology shall be members of said joint committee.

SECTION 2. It shall be the duty of said joint committee to investigate the organization and system of courts in Wisconsin, and to report the result of their investigation to the legislature that shall convene in 1915, with their recommendations as to such changes in the existing laws relating to the circuit or other courts of the state, as may be deemed necessary to promote efficiency and economy in the administration of justice.

SECTION 3. It is hereby made the duty of the clerk of each court of record, and of the judge of each court which shall be
