JOINT RESOLUTIONS

[Jt. Res. No. 1, A.] JOINT RESOLUTION NO. 1.

Relating to the death of Honorable Charles F. Ploeger.

Charles F. Ploeger, member of this assembly, was born Aug. 4, 1870, at Ellington, Outagamie County. In 1882 he moved with his parents to Seymour in the same county. He was educated in the common schools. He was a farmer and stock raiser and spent practically all his life on his farm in the town of Seymour. He was elected district school clerk in 1898 and served in that capacity up to the time of his death. In 1900 he was elected town clerk and served in that office for ten years; in 1910 he was elected town chairman. He also served for seven years as president of the Seymour Fair & Driving Park Association.

In all of these public offices Mr. Ploeger discharged the duties pertaining to them with ability and unquestioned integrity. He had large business interests, to which he gave his close attention, but when opportunity presented itself he was always ready to extend his influence toward the uplift of his community.

Since the last session of this legislature Mr. Ploeger has been taken from his labors by an untimely death, and his community and the state have been deprived of a valued and efficient force for good.

Therefore, as a mark of respect to his memory, be it

Resolved by the assembly, the senate concurring, That this resolution be entered on the journal of both houses and that an engrossed copy of the same, properly attested by the presiding officers of both houses, be transmitted to the family of the deceased.

[Jt. Res. No. 2, A.] JOINT RESOLUTION NO. 2.

Relating to the death of Assemblyman J. B. Jenson.

J. B. Jenson, a member of the assembly in 1913 and 1915, has been taken from this life since the last meeting of this legislature.

Mr. Jenson was born on a farm near Green Bay, Wisconsin, December 3, 1864. With his parents he moved to the town of Oakland, Jefferson County, in 1869, and in the spring of 1872 moved with his parents to the town of Westford, Richland County, and settled on a farm where he was engaged in farming, principally dairying.

During a long life of service he held various public offices and was directly and actively interested in the welfare of his community. For six years he served his town as chairman and for twenty-one years he was on the board of education. As a member of the legislature in 1913 and 1915 his interest in improving agricultural conditions was evidenced by his active work as a member of the committee on agriculture. His conscientious application and honesty in legislative work commanded the respect of all his associates.

As a mark of appreciation of the high character of Mr. J. B. Jenson and of his many public services be it

Resolved by the assembly, the senate concurring, That this memorial be entered upon the journals of the two houses and that an engrossed copy thereof, properly attested by the signatures of the presiding officers and chief clerks of the assembly and senate, be conveyed to the family of the deceased.

[Jt. Res. No. 2, S.] JOINT RESOLUTION NO. 3.

Relating to the death of Senator Robert Glenn.

Since this legislature was last in session Honorable Robert Glenn has been taken from us by death; he was born November 30, 1858, in Wyalusing, Wisconsin. Mr. Glenn was a man of sterling qualities and integrity. As a private citizen he gave freely of his time and effort to the up-building of his community and state; not only did he thus serve the people of his community and state as a private citizen, but he was for two years sheriff of Grant county, and for several terms a member of the county board, and was serving his first term in the state senate at the time of his death. His special life work was the conservation and preservation of state park lands at the confluence of the Wisconsin and Mississippi rivers. In the loss of Senator Glenn the people of his community, and of this state, have lost a faithful friend and public servant; therefore, be it

Resolved by the senate, the assembly concurring, That as a mark of respect, and as an expression of regard and esteem for the deceased, this resolution be spread upon the journal of each
