## CHAPTER 635.

AN ACT to amend subsections (1) and (2) of section 20.58 of the statutes, relating to oil inspection.

The people of the state of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Subsections (1) and (2) of section 20.58 of the statutes is amended to read: (20.58) (1) To the supervisor of inspectors of illuminating oils an annual salary of \* \* \* three thousand dollars.

(20.58) (2) To each deputy inspector of illuminating oils a salary, payable monthly, the amount thereof to be computed on the basis of the number of barrels containing not less than fifty gallons actually inspected by such deputy during the month, as follows: For each of the first \* \* \* one thousand, \* \* \* eight cents; for each of the \* \* next five hundred, \* \* five cents; for each of the \* \* next one thousand \* \* two cents; \* \* for each in excess of two thousand five hundred, \* \* one cent \* \*; but in no case shall a deputy inspector receive more than one hundred and fifty or less than fifty dollars in any month.

Section 2. This act shall take effect upon passage and publication.

## CHAPTER 636.

AN ACT to create subsection 3 of section 20.21, subsection 12 of section 20.60, and subsection 7 of section 20.62, relating to various departments and making appropriations.

The people of the state of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. A new subsection is added to section 20.21 to read: (20.21) (3) Annually, beginning July 1, 1919, not to exceed three thousand five hundred dollars to carry out the provisions of subsection 3 of section 41.035.

Section 2. A new subsection is added to section 20.60 to read: (20.60) (12) Annually, for two years beginning July 1, 1919, not to exceed four thousand one hundred twenty-five dollars for inspection of feeders and interstate shipments.

SECTION 3. A new subsection is added to section 20.62 to read: (20.62) (7) Annually, beginning July 1, 1919, not to exceed two

hundred fifty dollars for necessary expenses incurred in attending conventions and gatherings.

SECTION 4. This act shall take effect upon passage and publication.

## CHAPTER 637.

AN ACT levying the state taxes for the years 1919 and 1920 as required by section 5, article VIII of the Constitution.

The people of the state of Wisconsin, represented in Senate and Assembly, do enact as follows:

Section 1. To provide for the estimated expenses of the state of Wisconsin for the present fiscal year in excess of the income otherwise applicable thereto a state tax of one hundred dollars is hereby levied upon the taxable property of the state for the year 1919, in addition to all other taxes and charges authorized by existing laws for such year, such levying not to be increased or diminished by any executive or administrative officer, and the same shall be apportioned by the secretary of state to the several counties, and be apportioned according to law by the several county clerks of such counties to the taxing districts therein and be collected and accounted for according to law.

Section 2. To provide for the estimated expenses of the state of Wisconsin for the succeeding fiscal year, in excess of the income otherwise applicable thereto, a state tax of one hundred dollars is hereby levied upon the taxable property of the state for the year 1920 in addition to all other taxes and charges authorized by existing laws for such year, such levy not to be increased or diminished by any executive or administrative officer, and the same shall be apportioned by the secretary of state to the several counties, and be apportioned according to law by the several county clerks of such counties to the taxing districts therein and be collected and accounted for according to law.

SECTION 3. This act shall take effect upon passage and publication.
