CHAPTER 111.

AN ACT to amend section 45.06 of the statutes relating to rooms furnished by counties for use of veterans of World War.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Section 45.06 of the statutes is amended to read: 45.06 The action of any county board or municipality, or department thereof, in granting soldiers of the Civil War, * * * Spanish-American War, or World War, rooms and space within public buildings for the establishment of memorial halls and museums, and occupancy thereof by such ex-soldiers, is hereby authorized and confirmed. Such county board or municipality is hereby empowered and authorized to permit the use and occupancy of such rooms and space for such term and subject to such conditions and provisions as may be by them imposed, provided, however, that any contract, lien or agreement between said county board, municipality or department thereof and any such ex-soldiers of * * * the Civil, * * * Spanish-American or World Wars now in force shall continue in force according to the terms thereof.

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 112.

AN ACT to amend section 45.16 of the statutes, relating to the burial expenses of soldiers.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Section 45.16 of the statutes is amended to read: 45.16 Each town board, village board and the aldermen of each ward in every city, shall cause to be interred in a decent and respectable manner in any cemetery in this state, other than those

used exclusively for the burial of paupers, at an expense to the county of not less than thirty-five, nor more than * * * *one hundred* dollars, the body of any honorably discharged soldier, sailor or marine and the wives or widows of such soldiers, sailors or marines who shall have, at any time, served in the army or navy of the United States, and who shall die not leaving sufficient means to defray the necessary expenses of a decent burial, or under financial circumstances which would distress his family to pay the expenses of such burial.

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 113.

AN ACT to create section 19.07 of the statutes, relating to official bonds.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. A new section is added to the statutes to read: 19.07 Any number of public officers, employes, or agents may be combined in the bond prescribed in section 19.01 where the bond for such persons is required to be filed in the same place, and payment of the premium is required to be made from the same fund or appropriation.

SECTION 2. This act shall take effect upon passage and publication.
