### CHAPTER 332.

AN ACT to create subsection (1a) of section 103.43 of the statutes, relating to fraudulent advertising for labor.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. A new subsection is added to section 103.43 of the statutes to read: (103.43) (1a) A strike or lockout shall be deemed to exist as long as the usual concomitants of a strike or lockout exist; or unemployment on the part of workers affected continues; or any payments of strike benefits is being made; or any picketing is maintained; or publication is being made of the existence of such strike or lockout.

SECTION 2. This act shall take effect upon passage and publication.

### CHAPTER 333.

AN ACT to amend subsection (4) of section 20.09 of the statutes, relating to an appropriation to the tax commission for field accountants, assistants, and others, in checking up and verifying state income tax returns.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. Subsection (4) of section 20.09 of the statutes is amended to read: (20.09) (4) For the fiscal year beginning

July 1, \* \* \* 1925, one hundred thousand dollars and for the fiscal year beginning July 1, \* \* \* 1926, one hundred thousand dollars, for the salaries and necessary traveling expenses of field accountants, their assistants, and others, in checking up and verifying state income tax returns.

SECTION 2. This act shall take effect July 1, 1925.

### CHAPTER 334.

AN ACT to repeal subsection (1), paragraphs (e) and (g) of subsection (2), paragraph (b) of subsection (4), subsection (7), and subsection (8), all of section 20.40 of the statutes; paragraphs (d), (g), (k), (p), and (q) of subsection (1), and paragraphs (c) and (j) of subsection (3), all of section 20.41 of the statutes; to amend subsections (2), (3), (3a), (4), (5), and (6) of section 20.40 of the statutes; paragraphs (a), (ab), (c), (f) and (m) of subsection (1), paragraphs (a), (b), and (d) of subsection (2), paragraphs (b), (d), (e), (i), (m), (n), and (o) of subsection (3), subsection (7) and subsection (9), all of section 20.41 of the statutes; and to create paragraphs (ac), (c), (d), (g) and (n) of subsection (1), paragraphs (b) and (d) of subsection (2), paragraphs (b), (d), (e), (h), (i), (m), and (p) of subsection (3), paragraph (c) of subsection (4), subsection (9a), paragraph (b) of subsection (10), and subsection (11), all of section 20.40 of the statutes; paragraphs (ac), (d), (g), and (n) of subsection (1), paragraph (p) of subsection (3), and paragraph (b) of subsection (10), all of section 20.41 of the statutes, and making an appropriation to the University of Wisconsin.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. Subsection (1), paragraphs (e) and (g) of subsection (2), paragraph (b) of subsection (4), subsection (7), and subsection (8), all of section 20.40 of the statutes; paragraphs (d), (g), (k), (p), and (q) of subsection (1), and paragraphs (c) and (j) of subsection (3), all of section 20.41 of the statutes are repealed.
