CHAPTER 392.

AN ACT to repeal paragraph (d) of subsection (1) of section 20.60, relating to immigration work in the department of agriculture, subsection (2) of section 20.60, relating to bovine tuberculosis, subsection (3) of section 20.61, relating to state aid for the cranberry growers' association, and subsection (8) of section 94.07 of the statutes, relating to re-tests in area tested counties. To amend subsection (5), relating to grain rust, paragraphs (a), (b), and (e) of subsection (6), relating to the state fair, and subsection (9) of section 20.60 of the statutes, relating to the purchase of tuberculin. To create a new paragraph (d) to subsection (1), relating to immigration and research, paragraph (h) to subsection (1), relating to investigation and control of the diseases of the cranberry plant, subsection (2), relating to bovine tuberculosis, and paragraph (j) to subsection (6) of section 20.60 of the statutes, relating to a revolving fund for the state fair, and subsection (8) of section 94.07 of the statutes, relating to the payment of indemnities in area tested counties where a general retest is applied, and making appropriations to the department of agriculture.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Paragraph (d) of subsection (1) and subsection (2) of section 20.60 of the statutes, subsection (3) of section 20.61 of the statutes and subsection (8) of section 94.07 of the statutes are repealed.

Section 2. Subsection (5), paragraphs (a), (b), and (e). subsection (6), and subsection (9) of section 20.60 of the statutes are amended to read: (20.60) (5) * * * Annually, beginning July 1, * * * 1925, two thousand five hundred dollars, for the control of black stem rust of grains by means of barberry eradication; provided that the governor and commissioner of agriculture are authorized to discontinue any or all of the work provided for under this subsection, and in the event of such discontinuance, the appropriation herein made shall lapse.

(6) (a) * * * Annually * * beginning March 1, 1922, two hundred thirty thousand dollars, for the operation of the state fair. All moneys collected or received by each and every

person for or on account of the operation of the state fair shall be paid immediately into the general fund, except as provided in paragraphs (f), * * (g), and (j) of this subsection. The state treasurer and the secretary of state shall be in attendance at the state fair each year, respectively, then and there to receive such moneys and to audit and pay expenditures duly certified by the department of agriculture as having been necessarily incurred in the operation of the state fair. Of this there is allotted to each member of the state fair advisory board his actual and necessary expenses incurred in the discharge of his official duties; but no compensation for services except a per diem of five dollars for each day spent in assisting in the conduct of the state fair under the direction of the department of agriculture.

- (6) (b) On July 1, * * 1925, * * twenty thousand dollars, and on July 1, * * 1926, * * twenty thousand dollars, for equipment, permanent property and improvements, except the purchase of land.
- (6) (e) On July 1, * * * 1925, * * * twenty-five thousand dollars, and on July 1, * * * 1926, twenty-five thousand dollars, for property repairs and maintenance.
- (9) For the fiscal year beginning July 1, * * * 1925, * * four thousand dollars, and for the fiscal year beginning July 1, * * * 1926, * * * four thousand dollars, for the manufacture or purchase and distribution of tuberculin.
- Section 3. Two new paragraphs (d) and (h) to subsection (1), a new subsection (2), a new paragraph (j) to subsection (6) of section 20.60, and a new subsection (8) to section 94.07 are added to the statutes to read: (20.60) (1) (d) Annually, beginning July 1, 1925, twelve thousand dollars, for immigration work and research in the development of agriculture and industry as provided in subsections (1), (10), and (11) of section 93.07.
- (1) (h) Annually, beginning July 1, 1925, five thousand dollars, for investigation and control of diseases affecting the cranberry plant.
- (2) (a) On July 1, 1925, six hundred fifty thousand dollars, and annually beginning July 1, 1926, for a term of five years, seven hundred fifty thousand dollars, for the purposes of carrying on the work of bovine tuberculosis eradication and the payment of indemnities on animals condemned and slaughtered according to the provisions of chapter 94 of the statutes under the

area test plan, the accredited herd plan, and the local testing plan by established, practicing veterinarians whose work is approved by the department of agriculture. The entire appropriation shall be devoted to the payment of administrative cost and indemnities on animals condemned and slaughtered under the area test plan. the accredited herd plan, and the local testing plan in such proportions as the department of agriculture and the live stock sanitary board may deem advisable, provided that not to exceed three hundred thousand dollars may be used in any one year for the payment of indemnities on animals condemned and slaughtered by order of the state department of agriculture or the live stock sanitary board, but which are not included under the so-called area test plan or accredited herd plan of testing for bovine tuberculosis, and provided further that no funds appropriated in this section shall be expended for the payment of indemnities unless the animal or animals slaughtered shall have been tested in accordance with the regulations or permits of the state live stock sanitary board.

- (2) (b) Annually, beginning July 1, 1925, all moneys paid into the state treasury pursuant to subsection (8) of section 94.07 of the statutes are appropriated to the department of agriculture for the purposes set forth in paragraph (a) of this subsection, and are added to and made a part of said appropriation.
- (2) (e) Any balance remaining on June 30, 1925, in the appropriations made by subsection (2) of section 20.60 of the statutes shall go forward and be added to the appropriation made by paragraph (a) of this subsection and be available for the purposes thereof, any other provisions in this act to the contrary notwith-standing.
- (6) (j) All moneys received by each and every person through the operation of the boys' and girls' camps, teachers' camp, and the official dining hall at the state fair shall be paid within one week after receipt into the general fund and are severally appropriated therefrom to the department of agriculture for the carrying on of such activities.
- (94.07) (8) Each county that has been area tested shall, when a general re-test is applied to all of the cattle located within that county, and when re-tests subsequent thereto are applied to infected herds, be required to pay into the state treasury for each animal condemned and slaughtered a sum equal to one-fourth of

the difference between the net salvage and the appraised or agreed value of the condemned animal. No such payment shall exceed forty-five dollars for a registered bovine, or twenty dollars for an unregistered animal. After re-tests have been applied the department of agriculture shall report to the secretary of state the amount chargeable to the county and such amount shall be certified to the county clerk of the county in which re-tests were made, and it shall be levied, collected, and returned to the state treasurer as other state taxes are levied and collected and are reappropriated to the department of agriculture for the eradication of bovine tuberculosis and the payment of indemnities on condemned and slaughtered animals.

SECTION 4. This act shall take effect July 1, 1925. Approved June 26, 1925.

CHAPTER 393.

AN ACT to amend section 1 of chapter 186, laws of 1925, relating to a deficiency appropriation to the department of agriculture for the operation of the state fair for the fiscal year ending February 28, 1925, and making an appropriation.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

Section 1. Section 1 of chapter 186, laws of 1925, is amended to read: (Chapter 186, laws of 1925) (Section 1) There is appropriated from the general fund to the department of agriculture, * * the sum of fifteen thousand four hundred seventeen dollars in addition to all other appropriations heretofore made for the operation of the state fair for the fiscal year ending February 28, 1925.

Section 2. This act shall take effect upon passage and publication.
