Paragraph (Eleventh Circuit) of section 252.06 of the statutes is amended to read: (252.06) (Eleventh Circuit) In the county of Burnett on the third Monday of March and the first Monday of * * * *November*; in the county of Polk on the third Monday of April and the first Monday of * * * *October*; in the county of Barron on the first Monday of May and the third Monday of November; in the county of Washburn on the first Wednesday after the first Tuesday of April and the third Monday of October; in the county of Douglas on the first Monday of February and the fourth Monday of August.
