CHAPTER 126.

AN ACT to amend subsection (1) of section 27.01 of the statutes, relating to state parks.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Subsection (1) of section 27.01 of the statutes is amended to read: (27.01) (1) The state parks are designated as follows:

The state park in Polk county, as "Interstate Park of the Dalles of the St. Croix;"

The state park in the town of Gibraltar, Door county, as "Peninsula State Park;"

The state park in the town of Nasawauppee, Door county, as "Potowatomi State Park;"

The state park in the town of Wyalusing, Grant county, as "Nelson Dewey State Park;"

The state park in Sauk county, as "Devil's Lake State Park;"

The state park in the town of Delafield, Waukesha county, as "Cushing Memorial Park."

CHAPTER 127.

AN ACT to amend subsection (1) of section 27.01 and subsection (1) of section 29.565 of the statutes, relating to American Legion Memorial State Park and Forest Preserve.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Subsection (1) of section 27.01 and subsection (1) of section 29.565 of the statutes are amended to read: (27.01) (1) The state parks are designated as follows:

The state park in Polk county, as "Interstate Park of the Dalles of the St. Croix;"

The state park in the town of Gibraltar, Door county, as "Peninsula State Park;"

The state park in the town of Wyalusing, Grant county, as "Nelson Dewey State Park;"

The state park in Sauk county, as "Devil's Lake State Park;"

The state park in the town of Delafield, Waukesha county, as "Cushing Memorial Park;"

The state park in Oneida county, as "American Legion Memorial State Park and Forest Preserve."

(29.565) (1) All state owned land in * * * townships thirty-eight and thirty-nine north, range seven east, Oneida county, except that portion described in subsection (2), * * * is set aside as a state park and forest preserve to be known as the "American Legion Memorial State Park and Forest Preserve" and shall be managed and administered under the provisions of chapters 27 and 28 of the statutes. No hunting or trapping shall be allowed * * * in sections three, five, six, seven, eight, seventeen, eighteen, nineteen and twenty of township thirty-eight in said park. The conservation commission is authorized to enter into such arrangements with the Wisconsin department of the American Legion as may be mutually agreed upon * * * for the development and protection of said park and preserve * * * .

CHAPTER 128.

AN ACT to appropriate a sum of money as an emergency appropriation to the commissioner of insurance as ex officio fire marshal.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. There is appropriated from the general fund to the commissioner of insurance, as an emergency appropriation for the year ending June 30, 1929, three thousand three hundred
