CHAPTER 25.

AN ACT to amend subsections (2) and (3) of section 98.065 of the statutes, relating to the required equipment in powdered milk establishments.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Subsections (2) and (3) of section 98.065 of the statutes are amended to read: (98.065) (2) All buildings wherein the process of powdering is carried on shall be constructed and equipped to manufacture such powdered milk, buttermilk, skimmed milk or whey under clean and sanitary conditions. * * *

(3) All milk, skimmed milk, buttermilk or whey to be dried or powdered shall be kept at all times clean, not exposed to contamination, and shall not be handled or cared for in an unclean manner. All equipment used in such establishments and for the purpose of powdering or drying milk, buttermilk, skimmed milk or whey shall be kept in a clean and sanitary condition at all times. No special equipment shall be required in any butter factory or cheese factory, drying or powdering by-products of its own manufacture, which are intended for animal food only and so labeled, but a full line of equipment of such design and construction as to be easily accessible for cleaning and which shall be approved by the department of agriculture and markets, shall be installed in any factory or establishment where a dried or powdered by-product is manufactured which is intended for human consumption.

CHAPTER 26.

AN ACT to amend section 60.07 of the statutes, relating to town meetings.

Section 60.07 of the statutes is amended to read: 60.07 There shall be an annual town meeting * * * of each town on the first Tuesday of April at which all business shall be transacted which is by law required or permitted to be transacted at such meeting; and no notice of holding any annual town meeting need be given. The hour for holding succeeding annual town meetings may be fixed at any such meeting. Any annual or special town meeting may be held in the town or in any village or city within or adjoining the town.

AN ACT to amend section 222.13 of the statutes, relating to the investment of deposits of mutual savings banks.

Section 222.13 of the statutes is amended to read: 222.13 Any mutual savings bank organized hereunder may employ not exceeding one-half of its deposits in the purchase of the bonds of the United States or of the states of the United States or of the authorized bonds of any incorporated city, village, town or county, or school district in the aforesaid states of the United States or of first mortgage bond of any railroad company, which has paid annual dividends of not less than four per cent regularly
