## JOINT RESOLUTION

Relating to safety on highways.

Resolved by the Senate, the Assembly concurring, That the highway commission is hereby directed to appoint two persons within its organization and the public service commission is hereby directed to appoint one person in its organization, to be a committee, a part of whose duty shall be to collect, secure and assemble all possible data in regard to accidents on public highways and safety measures adopted by other states to the end that the 1935 legislature may have all possible information that may be used in the drafting of further safety highway legislation.

*Resolved further*, That suitable copies of this resolution be transmitted to the highway commission and to the public service commission.

## JOINT RESOLUTION

Memorializing the Congress of the United States to establish uniform rules and regulations for the movement of all commodities in interstate commerce.

WHEREAS, The federal constitution specifically provides that no state shall, without the consent of Congress, lay any imposts or duties on imports or exports, except what may be absolutely necessary for executing its inspection laws; and

WHEREAS, A number of states have been, and are now, providing embargoes on live stock, live stock products, dairy products, nursery plants, and other commodities under the pretense that such embargoes are necessary for executing their respective inspection laws; and

WHEREAS, Such embargoes have been, and now are, a serious handicap to the agricultural industry in this state; and

WHEREAS, The Congress of the United States, under its constitutional power to regulate commerce among the several states,
