CHAPTER 558.

AN ACT to amend 60.72 (1) of the statutes, relating to the disposal of garbage and rubbish.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

60.72 (1) of the statutes is amended to read:

60.72 (1) No person or municipality shall transport any garbage, rubbish or other refuse into or within any town for the purpose of dumping or otherwise disposing of the same until such person or municipality shall have first secured a permit so to do from the town board. This section shall not apply where the city or village owns its own dumping or disposal ground and confines its dumping or disposal to such grounds; provided, that ownership of such grounds was acquired by the city or village prior to June 1, 1943 and provided, that such disposal shall be conducted in a sanitary manner satisfactory to the state board of health.

AN ACT to appropriate sums therein named to the interim legislative committees created by Joint Resolution No. 52 (Joint Resolution No. 49, S.), Joint Resolution No. 21, S., Joint Resolution No. 31, S., Joint Resolution No. 40, S., and Joint Resolution No. 42, S. for the execution of their functions under said resolutions.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

There is appropriated from the general fund to the interim legislative committee to study the state budget system created by Joint Resolution No. 52 (Joint Resolution No. 49, S.) \$5,000, \$3,000 to the committee created by Joint Resolution No. 21, S., \$2,000 to the committee created by Joint Resolution No. 31, S., \$2,000 to the committee created by Joint Resolution No. 40 S., and \$2,000 to the committee created by Joint Resolution No. 42, S. for the execution of their functions under said resolutions.

There is appropriated from the general fund to the state department of public welfare \$30,000 as a nonlapsible appropriation for the purchase of approximately 40 acres of land and the buildings and equipment thereon, formerly owned by Normandale, Incorporated, situated about 2-½ miles west of the city of Madison, the purchase price thereof not to exceed \$30,000.

CHAPTER 561.

AN ACT to amend 20.33 (2) of the statutes, relating to state board of vocational and adult education and making an appropriation.

20.33 (2) of the statutes is amended to read:

20.33 (2) On July 1, 1943, \$255,000 and annually beginning July 1, 1944, \$420,000 for state aid for schools of vocational and adult education, established and maintained pursuant to section 41.15, and any school once granted such state aid shall be entitled thereto as long as the character of its work meets with the approval of the state board of vocational and adult education, to be distributed as provided in * * * section 41.21 (1).
