CHAPTER 515

AN ACT to amend and revise chapter 20 insofar as it relates to the finances of the highway fund constituting under the statutes a "budget bill" for the highway fund, and making appropriations beginning July 1, 1955 of \$78,675,138 and beginning July 1, 1956 of \$81,847,950.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 20.005 (3) of the statutes is created to read:

20.005 (3) HIGHWAY FUND. (b) *Appropriations financed from unassigned revenues (executive budget).* There is appropriated from the highway fund to the agency named for the purpose indicated:

SECTION 2. 20.052 (1a) of the statutes is repealed.

SECTION 3. 20.052 (1) of the statutes is amended to read:

20.052 (1) On July 1, * * * 1955, \$1,937,408, and annually, beginning July 1, * * * 1956, \$1,959,060, for the execution of its functions under chs. 85, 110 and 194, excluding postage and the purchase of license plates. * * *

SECTION 4. 20.49 (1), (1m) and (3) of the statutes are amended to read:

20.49 (1) On July 1, * * * 1955, \$2,167,662, and on July 1, * * * 1956, \$2,282,466 for its costs of administration, supervision and other expense of performing its administrative functions not otherwise financed. * * *

Any cash balance remaining under this subsection on August 31 following the close of any fiscal year shall be transferred to and is appropriated under s. 20.49 (9). Any prior year outstanding encumbrance and any claim of a prior fiscal year presented for payment after August 31 shall be charged to the appropriation made by this subsection for the current fiscal year in progress.

(1m) Annually, beginning July 1, * * * 1955, \$150,000 to the conservation fund as the state highway fund's share of advertising Wisconsin recreational facilities.

(3) Not to exceed * * * \$85,000 for the maintenance and operation of bridges as provided in s. 84.10.

SECTION 5. This act shall take effect on July 1, 1955; except that SECTION 2 shall take effect at the close of business on June 30, 1955.
