

CHAPTER 164

AN ACT to create 15.95, 71.04 (5) (d) 6 and 71.05 (6) (b) 9 of the statutes, relating to the establishment of a commission for the participation of Wisconsin in the New York World's Fair of 1964-65 and authorizing the deduction of contributions from the income tax.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. 15.95 of the statutes is created to read:

15.95 WORLD'S FAIR PARTICIPATION COMMISSION. There is hereby created a world's fair participation commission to direct Wisconsin's participation in the New York world's fair of 1964-65.

(1) COMPOSITION. The commission shall be composed of:

(a) A representative of the state department of agriculture selected by the board.

(b) A representative of the state department of resource development selected by the director.

(c) A representative of the conservation commission selected by the commission.

(d) A representative of the Wisconsin manufacturers association selected by the board of directors.

(e) A representative of the state chamber of commerce selected by the board of directors.

(f) A representative of the Wisconsin state AFL-CIO selected by the board of directors.

(g) A representative of the Wisconsin division of the American dairy association selected by the board of directors.

(h) A representative of the Wisconsin travel and tourist council selected by the board of directors.

(i) The lieutenant governor.

(j) Three senators and 3 assemblymen, including one member of the minority party in each house of the legislature, selected as are standing committees.

(2) OFFICERS. The governor shall be honorary chairman of the commission. The lieutenant governor shall be executive chairman of the commission. The commission shall elect a vice chairman and secretary from its membership.

(3) REMUNERATION. The members of the commission shall receive no compensation.

(4) MEETINGS. The commission shall meet at the call of the executive chairman.

(5) REPORTS. The commission shall make every effort to keep the legislature and the people of Wisconsin apprised of their progress in arranging for Wisconsin's participation in the New York world's fair of 1964-65.

(6) DUTIES. It is the duty of the commission to direct Wisconsin's participation in the New York world's fair of 1964-65. To this end it may, with the permission of the governor, create a public authority or private nonprofit corporation to plan, purchase or erect and manage any facility which would publicize Wisconsin to which the world's fair promoters would agree, to solicit and receive moneys from public and private sources to accomplish this purpose and to charge such fees and other charges in connection with the facility provided to permit the operation of such facility without financial loss.

SECTION 2. 71.04 (5) (d) 6 of the statutes is created to read:

71.04 (5) (d) 6. The state of Wisconsin for its promotional activities for the New York world's fair of 1964-65.

SECTION 3. 71.05 (6) (b) 9 of the statutes is created to read:

71.05 (6) (b) 9. The state of Wisconsin for its promotional activities for the New York world's fair of 1964-65.
