#### EXECUTIVE COMMUNICATION

The State of Wisconsin Executive Office Madison 53702

To the Honorable, the Legislature:

I have today signed Assembly Bill 99 (Chapter 43), and deposited it in the office of the Secretary of State.

While I approve the bill in its entirety, I have serious reservations with respect to the policy which calls for an automatic increase of eighty per cent (80%) of a full merit step for all eligible employees in range eight and below.

If the merit system does provide an incentive to the employees for meritorious performance, then it is my opinion that it is applicable to all ranges of civil service and should not be abandoned in ranges one through eight. I believe the automatic increase is an encroachment on the merit principle in Wisconsin, and I am asking the Joint Study Committee on Civil Service to carefully review this matter.

I have suggested to that committee that the action of the Legislature on the budget bill should not be considered a precedent, and I strongly urge that their recommendations with respect to our Merit Increase Law carefully consider retaining the principles of the merit system which have been such a vital part of our civil service process in Wisconsin
