RECOGNITION OF FORMER SPEAKERS OF THE ASSEMBLY

The speaker announced that two former speakers of the assembly were to be honored by the presentation of plaques of recognition and thanks for services and leadership rendered in fulfillment of their duties in a honored and highly responsible position.

The speaker called upon Assemblymen Obey and Tobiasz to escort to the rostrum the Honorable Robert T.
