VETO MESSAGE

To the Honorable, the Assembly:

I am returning **Assembly Bill 143** without my approval.

This legislation has a beneficial purpose in that it further implements the State Board of Health's measles immunization program. In my budget message to you, I recommended a statewide measles inoculation effort for pre-school children. Funds for such a program were provided for in the proposed budget. I strongly support such a program. However, I feel compelled to veto this bill because it would create several difficulties in carrying out such a program.

Bill 143, A., provides that no charge shall be made for the immunization program. Presently, the vaccine is furnished by the state and no charge is made for it. Where the vaccination is performed by a private physician, a charge is made for the physician's services. This bill would prohibit such a service charge and thus eliminate vaccination by private physicians from the immunization program. Such a result would impair the effectiveness of the program since to date 17,000 of the more than 70,000 children immunized have been vaccinated by private physicians.

The mandatory requirement for the immunization program as provided in this bill would also create difficulties. There is no exemption for children whose health might be seriously damaged by the injection of measles vaccine into their system or for those children who have acquired immunity as a result of having contracted the disease.

It is also questionable whether a mandatory immunization program is desirable. Research has indicated that if 70 per cent of the susceptible population is immune to measles, the occurrence of a measles epidemic is unlikely. In past immunization programs, voluntary procedures have been followed successfully. It would appear that establishing mandatory immunization programs through legislation is desirable only when a voluntary program is not successful.

For these reasons, I am returning **Assembly Bill 143** for further consideration by the Legislature.
