SPEAKER'S ANNOUNCEMENT OF APPOINTMENTS

The speaker announced the following appointments.

To the joint committee to Visit State Properties: Reappointments; Assemblymen Gee and Vanderperren. New appointments; Assemblymen Bock, Merkel, Schroeder and Grover.

The committee, composed of six assemblymen and five senators, visits all state institutions and properties to insure that proper use is being made of state facilities. It determines if they are being used in accordance with their intended purposes. Reports and recommendations are submitted to the legislature by the committee regarding the use of state properties.

To the joint committee for the Review of Administrative Rules. Reappointments; Assemblymen Shabaz and Thompson. New appointments; Assemblymen Stalbaum, Mathews and Pabst. The nine member joint committee of five Assemblymen and four Senators reviews administrative rules set forth by state agencies and has legislative power to suspend such rules.
