EXECUTIVE COMMUNICATION

GOVERNOR'S CALL FOR SPECIAL SESSION

A Proclamation

I, Warren P. Knowles, Governor of the State of Wisconsin, under and by virtue of Section 4 of Article V of the

JOURNAL OF THE ASSEMBLY [August 29, 1969]

Constitution of Wisconsin, which provides that the Governor shall have power to convene the Legislature on extraordinary occasions, do issue this, my proclamation, convening the Legislature of the State at the seat of government at Madison, on the twenty-ninth day of September, A. D., 1969, at two o'clock in the afternoon of that day, to consider and act upon the following subjects of legislative business, to-wit:

- (1) To provide the necessary appropriations to:
  - a. Fund experimental and model schools
  - b. Provide funds for teachers' aides and inter-related language skills centers
  - c. Provide funds for vocational and job training centers
  - d. Provide funds for consummation of pre-employment training contracts with private industry
  - e. Provide funds to aid local schools in developing pilot programs for the disadvantaged
  - f. Provide funds for administrative staff in the departments of public instruction and vocational education
  - g. Aid families with dependent children with unemployed parents
  - h. Provide aid for dependent children for stepchildren
  - i. Provide aid for dependent children over age 18 if they are in school
  - j. Provide public assistance grants under AFDC at current level
  - k. Provide for medical assistance under the group II medical program to low-income citizens
  - l. Provide state assistance to the Marquette Medical School
  - m. Assist Milwaukee in its increased Model Cities effort
  - n. Provide grants to improve state services in the Model Cities program
  - o. Provide matching grants to communities for community improvement programs
  - p. Provide housing grants to assist sponsors of low-cost housing
  - q. Create revolving housing loan fund to assist low-income and elderly families
  - r. Provide funds to continue special projects in the Milwaukee inner core

- s. Provide funds for the administration of the programs outlined in points m, n, o, p, q and r above
- t. Initiate a comprehensive community health program
- u. Expand programs for water and air pollution abatement

(2) Provide the necessary revenues to fund the aforementioned programs including the necessary funds to implement tax redistribution as recommended by the Tarr Task Force.

IN WITNESS WHEREOF, I have hereunto set my hand and caused the Great Seal of the State of Wisconsin to be affixed. Done at the Capitol in the City of Madison this twenty-ninth day of August in the year of our Lord one thousand nine hundred and sixty-nine.
