The ayes and noes were required and the vote was: ayes, 0; noes, 26; absent or not voting, 6; as follows:

Noes—Senators Busby, Chilsen, Dempsey, Devitt, Draheim, Heinzen, Hollander, Johnson, Kendziorski, Keppler, Knowles, Knutson, Krueger, LaFave, Lorge, Lotto, Lourigan, McParland, Meunier, Rasmusen, Risser, Roseleip, Schreiber, Schuele, Soik and Swan—26.

Absent or not voting—Senators Cirilli, Dorman, Terry, Thompson and Whittow—5.

Less than two-thirds having voted in the affirmative, the senate refused to pass the bill nowithstanding the objections of the Governor.

Senator Kendziorski in the chair.

Upon motion of Senator Keppler, with unanimous consent, Senate Bill 602 was taken up before Senate Bill 223.

Senate Bill 602

An act requiring legislative ratification of the establishment of administrative districts of regions for state agency operations.

The question was: Shall the bill pass notwithstanding the objections of the Governor?

The ayes and noes were required and the vote was: ayes, 22; noes, 6; absent or not voting, 3; as follows:

Ayes—Senators Busby, Chilsen, Dempsey, Devitt, Hollander, Johnson, Kendziorski, Keppler, Knutson, Krueger, LaFave, Lorge, Lotto, Lourigan, McParland, Meunier, Rasmusen, Roseleip, Schuele, Soik, Swan and Terry—22.

Noes—Senators Draheim, Heinzen, Knowles, Risser, Schreiber and Thompson—6.

Absent or not voting—Senators Cirilli, Dorman and Whittow—3.

More than two-thirds having voted in the affirmative, the bill passed notwithstanding the objections of the Governor.

Upon motion of Senator Keppler, with unanimous consent, the actions of the senate were ordered immediately messaged to the assembly.

Upon motion of Senator Keppler, with unanimous consent, Senate Bill 223 and Assembly Bill 332 were placed on the calendar after Senate Bill 660.

Senate Joint Resolution 82

A joint resolution relating to uniformity of taxation. Read.

The resolution was rejected.

Upon motion of Senator Swan, with unanimous consent, the bill was placed on the calendar after Senate Bill 89.

Relating to officers nominated by the governor, and with the advice and consent of the senate appointed.

Read a second time.

Senate substitute amendment 1 was adopted.

The bill was ordered to a third reading.

Upon motion of Senator Keppler, with unanimous consent, the bill was considered for final action at this time.

Upon motion of Senator Keppler, with unanimous consent, Senate Bill 210 was placed on the calendar after Senate Bill 554.

Upon motion of Senator Johnson, with unanimous consent, Senate Bill 364 was placed on the calendar after Senate Bill 27.

Senate Joint Resolution 82

Senator Risser moved reconsideration of the vote by which the resolution was rejected and it be placed on the calendar after Senate Bill 364.

Senator Schreiber, with unanimous consent, was granted a leave of absence from 11:00 A.M. to 11:40 A.M. of today's session.

Senate Bill 554

Relating to annexation of town islands.

Read a second time.

The question was: Shall the bill be indefinitely post-poned?

Senate amendment 1 to Senate Bill 554 offered by Senator Keppler.

Upon motion of Senator Hollander, with unanimous consent, senate amendment 1 was considered before the vote on indefinite postponement.

Senator Soik moved rejection of the amendment.

The motion did not prevail.

President pro tempore in the chair.

Senate amendment 1 was adopted.

Senate amendment 2 offered by Senator Lorge and considered at this time with unanimous consent.

Senator Risser moved rejection of senate amendment 2.

Upon motion of Senator Keppler, with unanimous consent, Senator Lotto was granted a leave of absence for the balance of today's session.

The question was: Shall senate amendment 2 be rejected?

The ayes and noes were demanded and the vote was: ayes, 13; noes, 12; absent or not voting, 6; as follows:

Ayes—Senators Busby, Chilsen, Draheim, Heinzen, Hollander, Kendziorski, Keppler, Knowles, Rasmusen, Risser, Schreiber, Schuele and Soik—13.

Noes—Senators Dempsey, Devitt, Johnson, Knutson, La-Fave, Lorge, Lourigan, McParland, Meunier, Roseleip, Swan and Terry—12.

Absent or not voting—Senators Cirilli, Dorman, Krueger, Lotto, Thompson and Whittow—6.

So the motion to reject prevailed.

Senator McParland moved to lay the bill over and place Senate Bill 554 on the calendar after Senate Bill 364.

The question was: Shall the bill lay over?

The ayes and noes were demanded and the vote was: ayes. 9; noes, 17; absent or not voting, 5; as follows:

Ayes—Senators Busby, Chilsen, Dempsey, Keppler, La-Fave, Lourigan, McParland, Roseleip and Soik—9.

Noes—Senators Devitt, Draheim, Heinzen, Hollander, Johnson, Kendziorski, Knowles, Knutson, Krueger, Lorge, Meunier, Rasmusen, Risser, Schreiber, Schuele, Swan and Terry—17.

Absent or not voting—Senators Cirilli, Dorman, Lotto, Thompson and Whittow—5.

The motion to lay the bill over failed.

The question was: Shall Senate Bill 554 be indefinitely postponed?

The ayes and noes were demanded and the vote was: ayes, 12; noes, 15; absent or not voting, 4; as follows:

Ayes—Senators Dempsey, Devitt, Johnson, Knutson, La-Fave, Lourigan, McParland, Meunier, Roseleip, Swan, Terry and Thompson—12.

Noes—Senators Busby, Chilsen, Draheim, Heinzen, Hollander, Kendziorski, Keppler, Knowles, Krueger, Lorge, Rasmusen, Risser, Schreiber, Schuele and Soik—15.

Absent or not voting—Senators Cirilli, Dorman, Lotto and Whittow—4.

So the senate refused to indefinitely postpone the bill.

The bill was ordered to a third reading.

Senator Keppler asked unanimous consent the bill be considered for final action at this time.

Senator McParland objected.

Upon motion of Senator Keppler, with unanimous consent, the senate returned to the 5th order of business.

Whereas, all persons mourn the tragic death of this young man, who died in the line of duty and while he was on a mission to protect the seat of representative government in our state; now, therefore,

The Members of the Wisconsin Senate, on the motion of Senator LaFave, extend their heart-felt sympathy to the family of Sgt. Felipe K. Fernandez who gave his life in the service of his state and direct that in tribute to Sgt. Fernandez the Assembly and Senate flags be flown at half-staff for the remainder of this week.
