#### RESOLUTIONS

## Senate Resolution 24

Urging the governor to seek release from the board on government operations of funds distributable to the university of Wisconsin, in accordance with the legislative intent, because of enrollment increases at the university.

Whereas, a key element in the eventual compromise on and enactment of a budget act for the 1969-71 biennium was the creation of an appropriation for workload increases at the university of Wisconsin, from which funds were to be released by the board on government operations if enrollments increased at the university of Wisconsin; and

Whereas, it was known to all members of the committee of Conference on the budget, to all legislative participants and to all observers of the legislative process that the sole factor which was to be demonstrated by the university to gain release of the funds was—in the words of the controlling statute—"enrollment increases at a particular campus"; and

Whereas, it now appears that there is an attempt in certain quarters to cynically thwart this clearly, understood intent of the legislature notwithstanding the fact that enrollments have increased; now, therefore, be it

Resolved by the senate, That the governor is respectfully urged to seek again release from the board on government operations of moneys appropriated for the use of the university of Wisconsin, which were clearly intended to be available upon a showing by the university that enrollment increases have taken place, a situation which has demonstrably come to pass.

#### Senate Resolution 25

Requesting an opinion of the attorney general as to the authority of the board on government operations during periods when the legislature is in actual session, and as to the legislature's authority to release funds distributable through the board by some other means.

Whereas, the board on government operations is an out-

growth of the old "emergency board" which was established to operate as a surrogate for the legislature during periods when the legislature was not in session; and

Whereas, certain questions have now arisen as to the board's adherence to its charge from the legislature to disburse money in accordance with clear legislative intent, and these questions raise even broader questions as to the extent to which legislative power may appropriately be delegated to, and exercised by, the board while the legislature is meeting; now, therefore, be it

Resolved by the senate, That the attorney general is requested to provide an opinion as expeditiously as possible as to the following questions:

- (1) What is the authority of the board on government operations during periods when the legislature is in actual session?
- (2) May the legislature by joint resolution order the board on government operations, a legislative body consisting solely of legislative members, to release these funds if it finds that the board has failed to carry out its instructions in accordance with the pertinent legislative directive?
- (3) May the legislature, while in actual session, release funds designated for release through the board through some other expression of legislative will that the funds be released such as a joint resolution?

Senate Rule 63 (3) No proposal having been twice indefinitely postponed and twice revived may again be indefinitely postponed until all amendments are considered which were pending at the time the 3rd or subsequent motion for indefinite postponement was made.
