# **1970 Special Session**

# TUESDAY, December 22, 1970.

### 2:00 o'clock P.M.

The legislature of the state of Wisconsin met in special session at Madison, the capital city, on Tuesday, December 22, A.D. 1970, at 2:00 o'clock p.m., pursuant to proclamation of the Governor.

The senate was called to order by the Honorable Jack B. Olson, president of the senate.

Prayer was offered by Father Dave Baker, St. James Catholic Church, Madison.

The senate remained standing for Pledge of Allegiance.

The president announced that a call for a special session had been issued by the Governor and directed the chief clerk to read the proclamation by the Governor.

### A Proclamation

I, Warren P. Knowles, Governor of the State of Wisconsin, under and by virtue of Section 4 of Article V of the Constitution of Wisconsin, which provides that the Governor shall have power to convene the Legislature on extraordinary occasions, do issue this, my proclamation, convening the Legislature of the State at the seat of government at Madison, on the twenty-second day of December, A.D., 1970.

Senate Resolution 1, Special Session

Sec. 4

Relating to organization of the senate for the 1970 special session.

Whereas, the officers of the 1969 regular session are by statute the officers of the 1970 special session; now, therefore, be it

Resolved by the senate, That the organization, including the committees and the memberships thereof, of the senate for the 1969 regular session, be the same for the 1970 special session; and, be it further

Resolved, That during the 1970 special session all members shall be assigned the same seats as during the 1969 regular session; and, be it further

Resolved, That during the special session of 1970 the rules of the senate adopted during the 1969 regular session be adopted as the rules of the 1970 special session except as they are changed by the following special rules adopted in consequence of the limitations of the call for the special session:

(1) No memorials to congress shall be considered by the senate.

(2) No senate resolutions shall be considered except those recommended for introduction by the committee on legislative procedure or by unanimous consent.

(3) No senate bills shall be considered.

(4) No notice of hearings before committees shall be required other than posting on the legislative bulletin boards, and no bulletin of committee hearings shall be published.

(5) All motions to reconsider shall be taken up immediately. Be it further

Resolved, That the chief clerk is instructed to notify the
