Assembly Bill 192

It is the feeling of this committee that the matter of state pick-up of retirement contributions for faculty members of the University of Wisconsin and State Universities is an integral part of the process of determination of employe

compensation. Recognizing that this committee is not passing judgement on total compensation levels of faculty members, it is the opinion of this committee that in keeping with the philosophy of standardized benefits for the various members of the several state supported retirement systems the provisions contained in the bill are meritorious. In as much as the bill is in the best public interest but is in need of technical clarification this committee recommends passage of Assembly Substitute Amendment 1.
