ON TAX EXEMPTIONS**

Assembly Bill 185

Public Policy Involved

In 1965 it was the legislature's intent that Wisconsin simplify its income tax law by adopting as much of the federal income tax code as was possible. This bill is undesirable as a matter of public policy because it adds one more subtraction modification to the Wisconsin tax code and thus moves away from simplification. Adoption expenses are not deductible under federal tax law.

Assembly Bill 375

Public Policy Involved

This bill is desirable public policy. For corporations the proposal does three things. First, it helps standardize the tax treatment of corporations under Wisconsin and federal statutes. Second, it clarifies an ambiguity in the interpretation of the tax treatment of convertible debentures. Finally, this proposal limits the deduction at time of bond redemption to true interest expense on the obligation.

For individuals this bill corrects an inequity caused by changes in the federal tax law. Wisconsin uses the federal definition of income but has to make certain adjustments. One of these is in the area of capital gains and losses. Before the Federal Tax Reform Act of 1969, Wisconsin taxed 100%

of capital gains and allowed 100% of long term losses. The federal reform changed the basis of computation. For a Wisconsin taxpayer this had the effect of taxing 100% of gains, but allowing only 50% of long term losses. This bill returns Wisconsin to its former basis and corrects the unintended inequity caused by the federal statute change.
