INTRODUCTION AND REFERENCE OF RESOLUTIONS

Read and referred:

Assembly Resolution 13

To renumber assembly rule 20 (2); to amend assembly rule 5 (11); and to create assembly rule 20 (b) and (c), relating to minority representation on standing committees.

Analysis by the Legislative Reference Bureau

This resolution requires that the membership of assembly standing committees reflect fractionally the political composition of the assembly. It further specifies that minority members of standing committees are appointed by the minority leader.

Resolved by the assembly, That:

SECTION 1. Assembly rule 5 (11) is amended to read:

RULE 5 (11) *To Except as provided in assembly rule 20 (2) (c), to appoint the members to all the committees of the assembly and to joint committees as required by statutes, joint rules, by rules of the assembly or other directives.*

SECTION 2. Assembly rule 20 (2) is renumbered assembly rule 20 (2) (a).

SECTION 3. Assembly rule 20 (2) (b) and (c) are created to read:

RULE 20 (2) (b) Each standing committee of the assembly shall reflect, as close as possible and with fractions resolved in favor of the majority party, the political composition of the assembly.

(c) The speaker shall appoint the majority party members of each assembly committee. The minority leader shall appoint the minority party members of each assembly committee.
