JOINT SURVEY COMMITTEE ON RETIREMENT SYSTEMS

Assembly Bill 354

In as much as this bill would establish the undesirable precedent of excluding earnings from retirement benefits, create additional administrative workloads, and further confuse the present issue, it is the opinion of this committee that passage of this bill is not in the best public interest.

Assembly Bill 437 and Assembly Amendment 1

The Retirement Research Committee developed standards and criteria for protective occupation coverage, which is contained in Chapter 355, Laws of 1967, and consequently positions not meeting the criteria were justifiably removed as of July 1, 1969.

If this bill is passed problems will develop in the following areas:

First, it would allow approximately 247 employes to regain coverage as protective occupation participants, even though they do not meet the eligibility criteria for such membership.

Second, the employer contribution costs would be increased \$719,302 for the next biennium of which 100% would be paid from segregated funds.

Third, the bill establishes a very poor precedent, which completely subverts the intent of Chapter 355, Laws of 1967.

Therefore, it is the opinion of this committee that this bill and the assembly amendment thereto are not in the best public interest and are not deserving of passage.
