Assembly Resolution 15

Relating to requesting the attorney general to seek an injunction prohibiting abortions in this state.

Whereas, pending final decision in the current federal case testing this state's abortion statute (McCann v. Babbitz), the current limits and meaning of state regulation of abortion are uncertain; and

Whereas, abortions are allegedly being performed at this time by doctors and clinics in the state, including the Midwest Medical Clinic of Madison; and

Whereas, both doctors and prosecutors are confused about their rights and duties under the present situation; now, therefore, be it

Resolved by the assembly, That the attorney general is hereby requested to institute proceedings in the appropriate court to obtain an injunction prohibiting the Midwest Medical Clinic of Madison and all doctors and clinics in the state from performing abortions until a definite rule affecting Wisconsin has been settled upon in the federal courts.
