COMMITTEE REPORTS JOINT SURVEY COMMITTEE ON TAX EXEMPTIONS

Assembly Bill 77 Assembly Amendment 1

Public Policy Involved

This bill is not desirable because it broadens the exemptions for occasional sales and charitable organizations to the point where sellers who are truly neither occasional nor charitable will qualify for an exemption. Under present law, reasonable provisions exist to protect private firms from competition of tax free sales, yet avoiding nuisance collection problems associated with events small in size and infrequent in occurrence.

Assembly Bill 154

Public Policy Involved

This bill is not desirable public policy. An exemption exists for sales to groups organized exclusively for religious, charitable, scientific or educational purposes. If veterans organizations do not qualify under that section, there is

little reason to suppose that they differ from other community groups which benefit both their members and the community but which must pay the sales tax.

Assembly Bill 179

Public Policy Involved

This is not desirable as a matter of public policy. Servicemen presently receive two types of tax benefits as a result of their status. The first \$1,000 of income received from the federal government either as an active or reserve member of the armed forces is excluded from income, as is all combat zone pay up to \$500 a month for officers and all enlisted men's pay, including pay received while hospitalized as a result of injuries suffered in a combat zone.

A serviceman is required to maintain a state of residence during his military service. In this time he may be stationed in many states. The Soldiers and Sailors relief act provides that he may only be taxed on his service income by his state of residency. This protects him from multiple and confusing tax claims by states whose tax levies may be more or less severe than that of his home state.

Servicemen who maintain their Wisconsin residence but who are stationed outside the state would seem to impose little direct burden to the state. Yet, like other Wisconsin citizens, they may claim certain privileges which all Wisconsin residents pay toward but not all claim, like resident university tuition and resident hunting and fishing licenses. That their status is somewhat different from other residents is already recognized in the two exclusions previously cited which are offered no other group of Wisconsin residents.

Assembly Bill 230

Public Policy Involved

This bill is desirable as a matter of public policy. It will result in the collection of data about the extent and value of property now exempt from taxation. The information gathered also will enable an assessor to determine whether property should continue to enjoy exempt status.

Assembly Bill 461

Public Policy Involved

The taxes on motor fuel and special fuels are imposed on motor vehicles driven on Wisconsin's roads. Both laws dedicate the tax to the highway fund. Portions of both taxes are returned to localities as highway aid. Both laws contain provisions for tax free use off the road either through refunds or in imposition of the tax. The law is clear. If a motor vehicle is driven on the road, its fuel is taxed, be it driven by the state, its subdivisions or private citizens. Electing to exempt the tax on special fuels (e.g. diesel) used in trucks owned by localities and to continue taxing gasoline used in other trucks operated by the same units of government creates an artificial advantage for one type of propellant over the other. The accounting problems posed municipalities for special fuel are no more complicated than that the state imposes on private citizens for gas tax refunds. For these reasons, this bill is poor public policy.

Assembly Bill 552

Public Policy Involved

Attempting to encourage employers to recruit and train hard core unemployed through a tax exemption for on-the-job training is likely to be neither effective nor efficient. Ambiguities inherent in the definition of hard core unemployed on-the-job training, and overhead costs would make administration of the proposal difficult and perhaps inequitable. Additionally, there is serious doubt about the constitutionality of this proposal. For these reasons this bill is not desirable public policy.
