Public Policy Involved

It is desirable public policy to establish similar exemptions for similar organizations as provided by this bill.

Public Policy Involved

This bill is not desirable as a matter of public policy. While it would tax insurance companies now exempt, it continues to differentiate between mutual and stock companies. By allowing certain companies to offset taxes paid the state by personel property taxes paid to municipalities, the bill subsidizes some communities at the expense of the state's general fund and ultimately, all other taxpayers.

Public Policy Involved

This is not desirable as a matter of public policy. Servicemen presently receive tax benefits as a result of their status.

A serviceman is required to maintain a state of residence during his military service. In this time he may be stationed in many states.

The Soldiers and Sailors Relief Act provides that he may be taxed only on his service income by his state of residency. This protects him from multiple and confusing tax claims by states whose tax levies may be more or less severe than that of his home state. That their status is somewhat different from other residents is already recognized in the exclusions which are offered no other group of Wisconsin residents.
